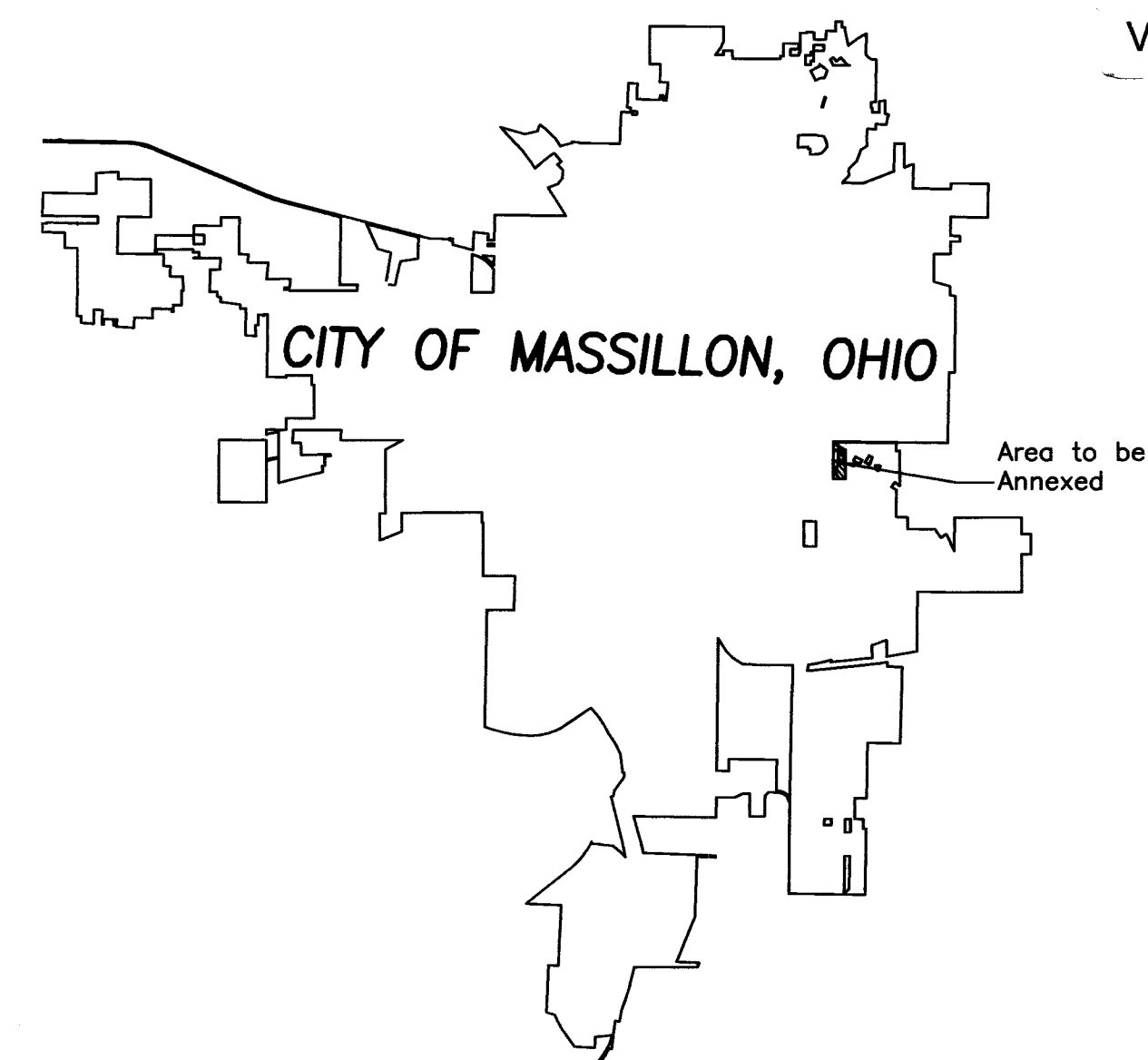


**BASIS OF BEARING**

MAP OF TERRITORY TO BE ANNEXED TO THE CITY OF MASSILLON, OHIO

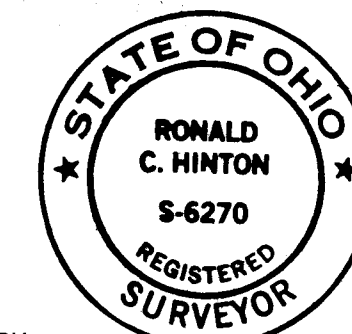

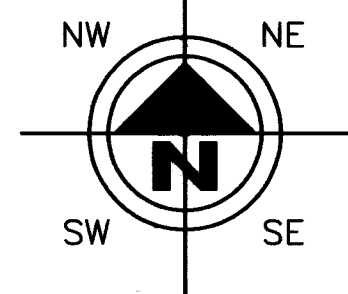
