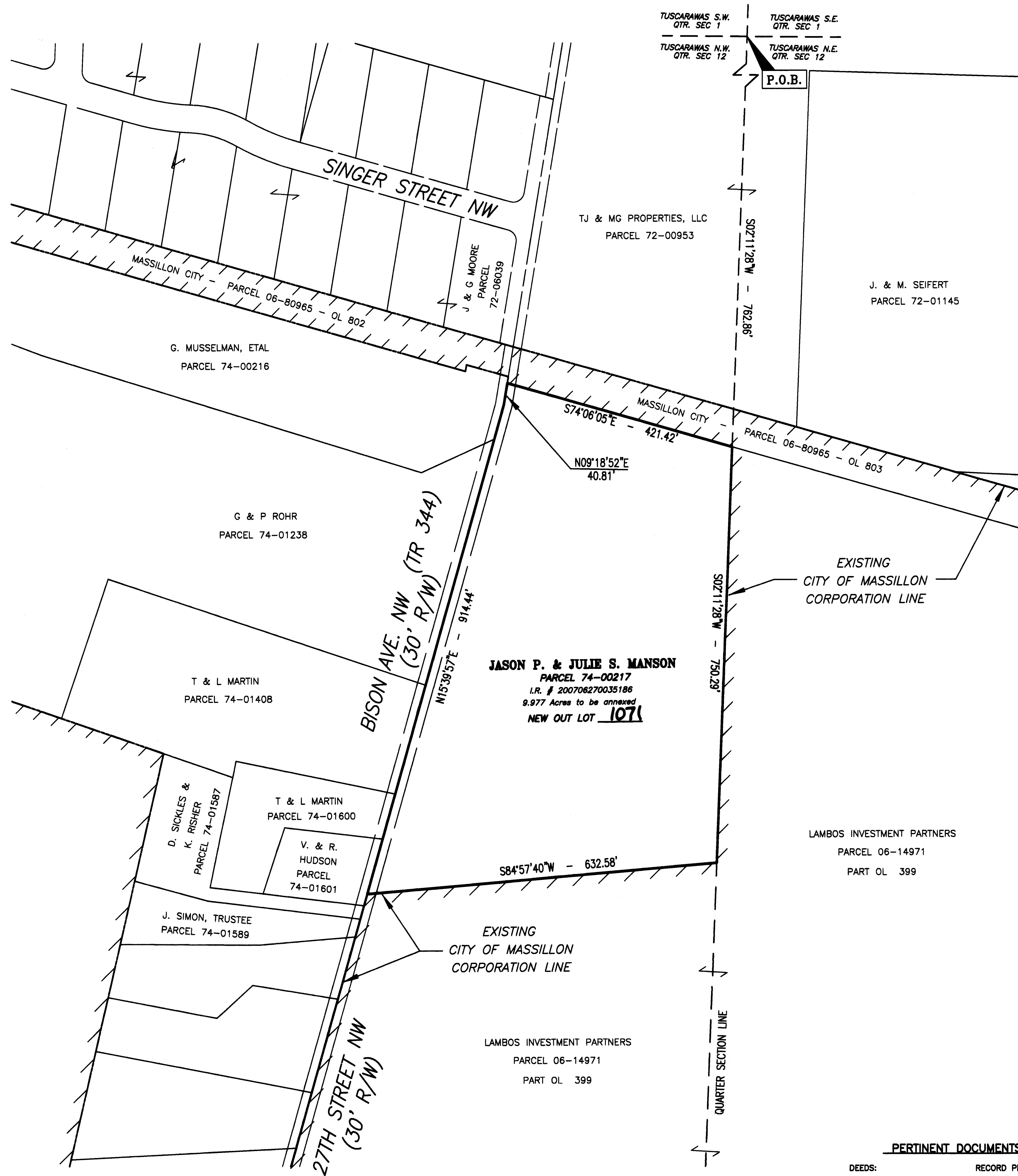
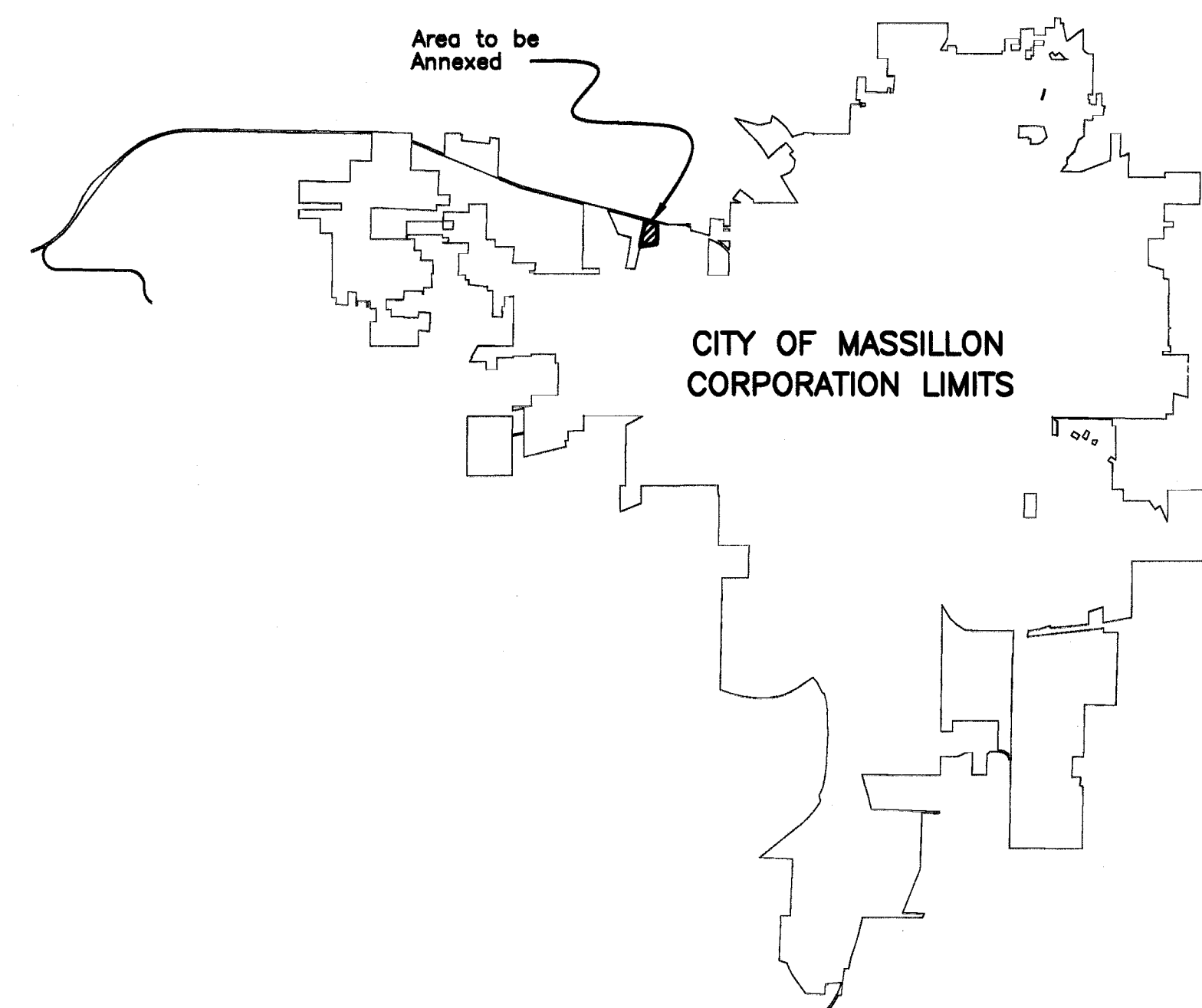




NOTE:

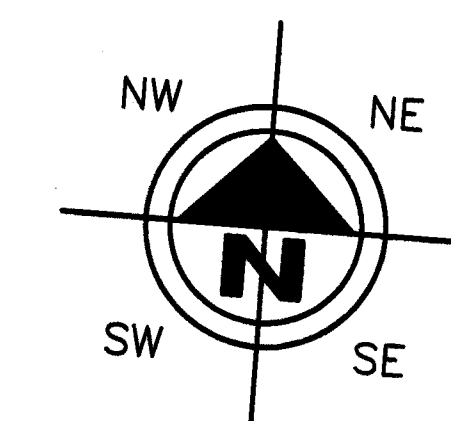
