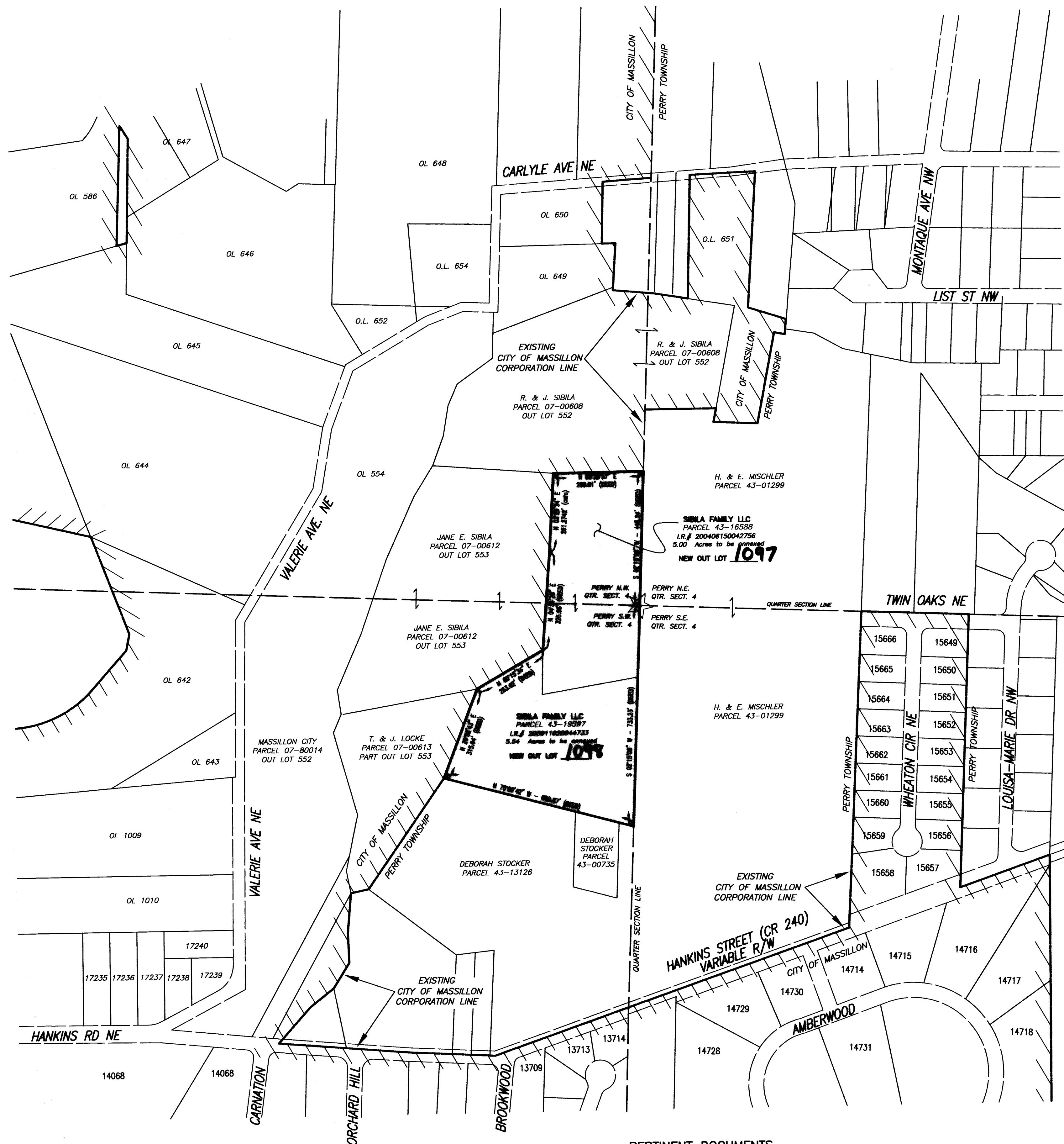




BASIS OF BEARING

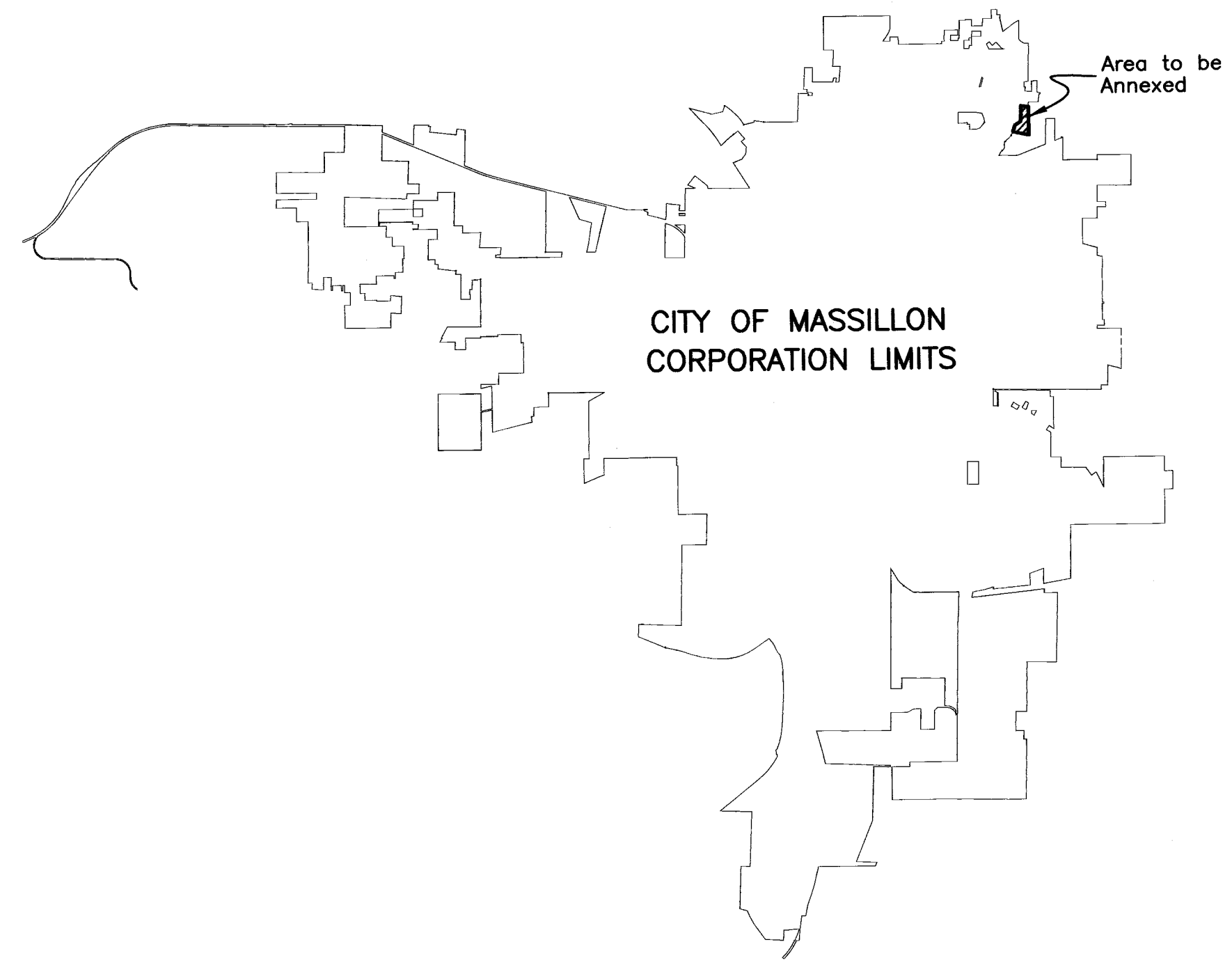

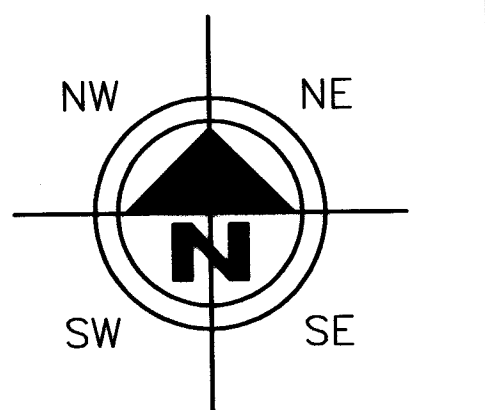
