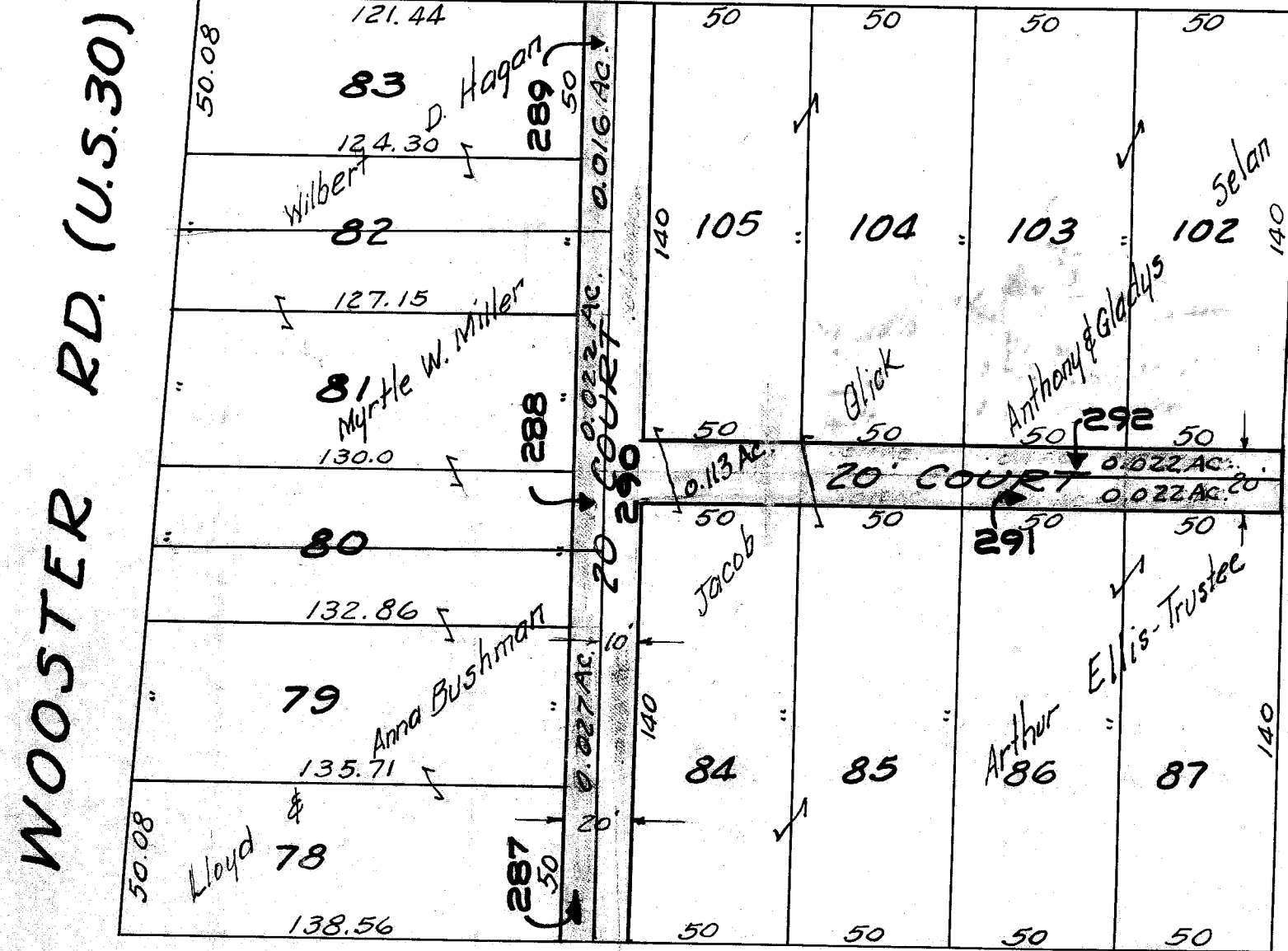




Total Acreage vacated courts = 0.22 Acres
