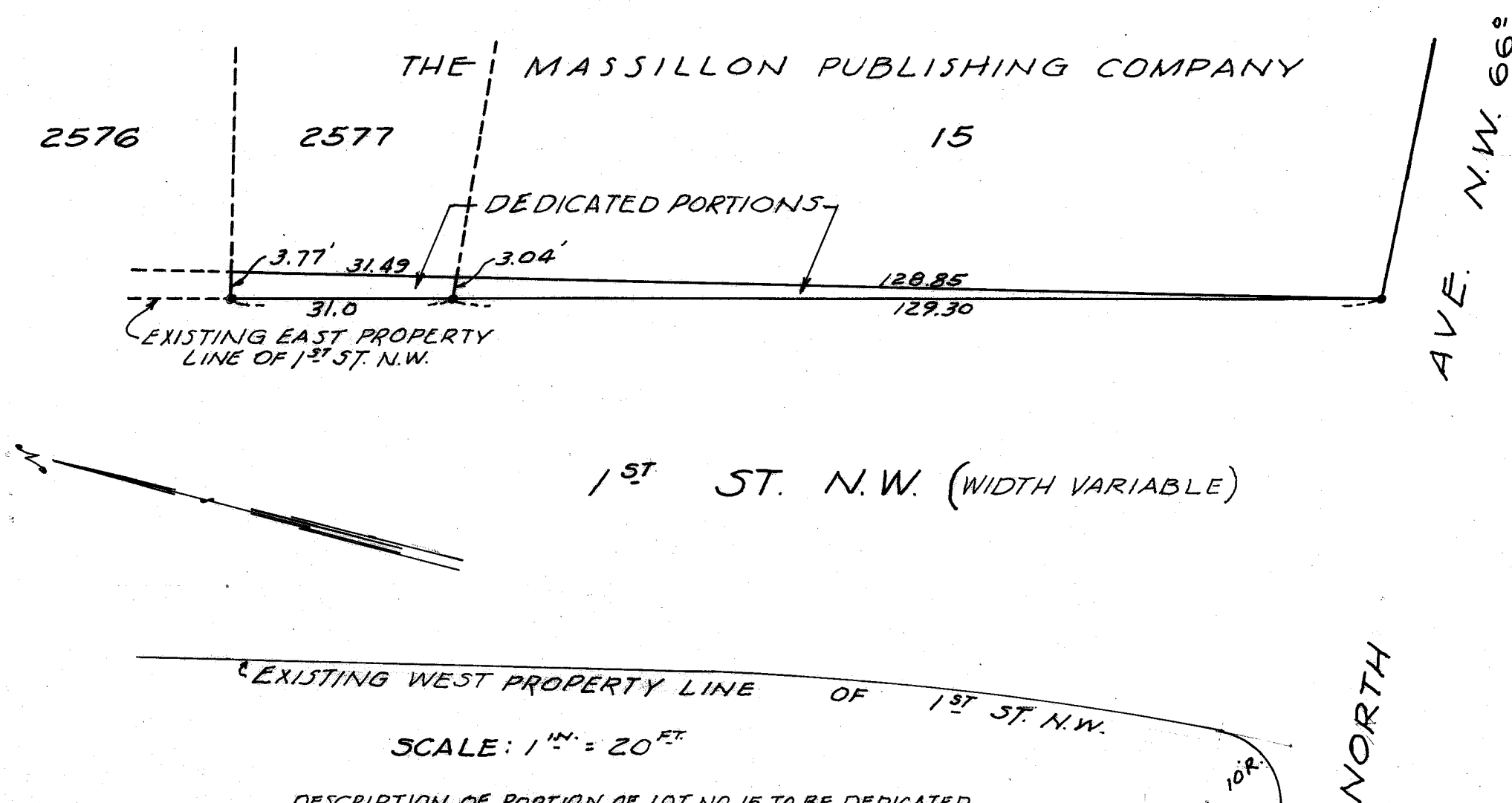




SCALE: 1" = 20'

DESCRIPTION OF PORTION OF LOT NO. 15 TO BE DEDICATED

Beginning at an Iron Pin at the S.W. corner of Lot No. 15, said point being the true place of beginning of the parcel herein to be dedicated; thence northerly along the east line of 1st St. N.W. a distance of 129.30 feet to an Iron Pin at the N.W. corner of Lot No. 15; thence easterly along the north line of said Lot No. 15 a distance of 3.04 feet to a point; thence southerly a distance of 128.85 feet to the place of beginning containing 196 sq. ft.

DESCRIPTION OF PORTION OF LOT NO. 2577 TO BE DEDICATED

Beginning at an Iron Pin at the southwest corner of Lot No. 2577, said point being the true place of beginning of the parcel herein to be dedicated; thence northerly along the west line of said Lot a distance of 31.0 feet to the northwest corner of said Lot No. 2577; thence easterly along the north line of said Lot a distance of 3.77 feet to a point; thence southerly a distance of 31.49 feet to a point on the south line of Lot No. 2577, 3.04 feet east of the southwest corner of said Lot; thence westerly along the south line of Lot No. 2577 a distance of 3.04 feet to the place of beginning containing 107 sq. ft.
