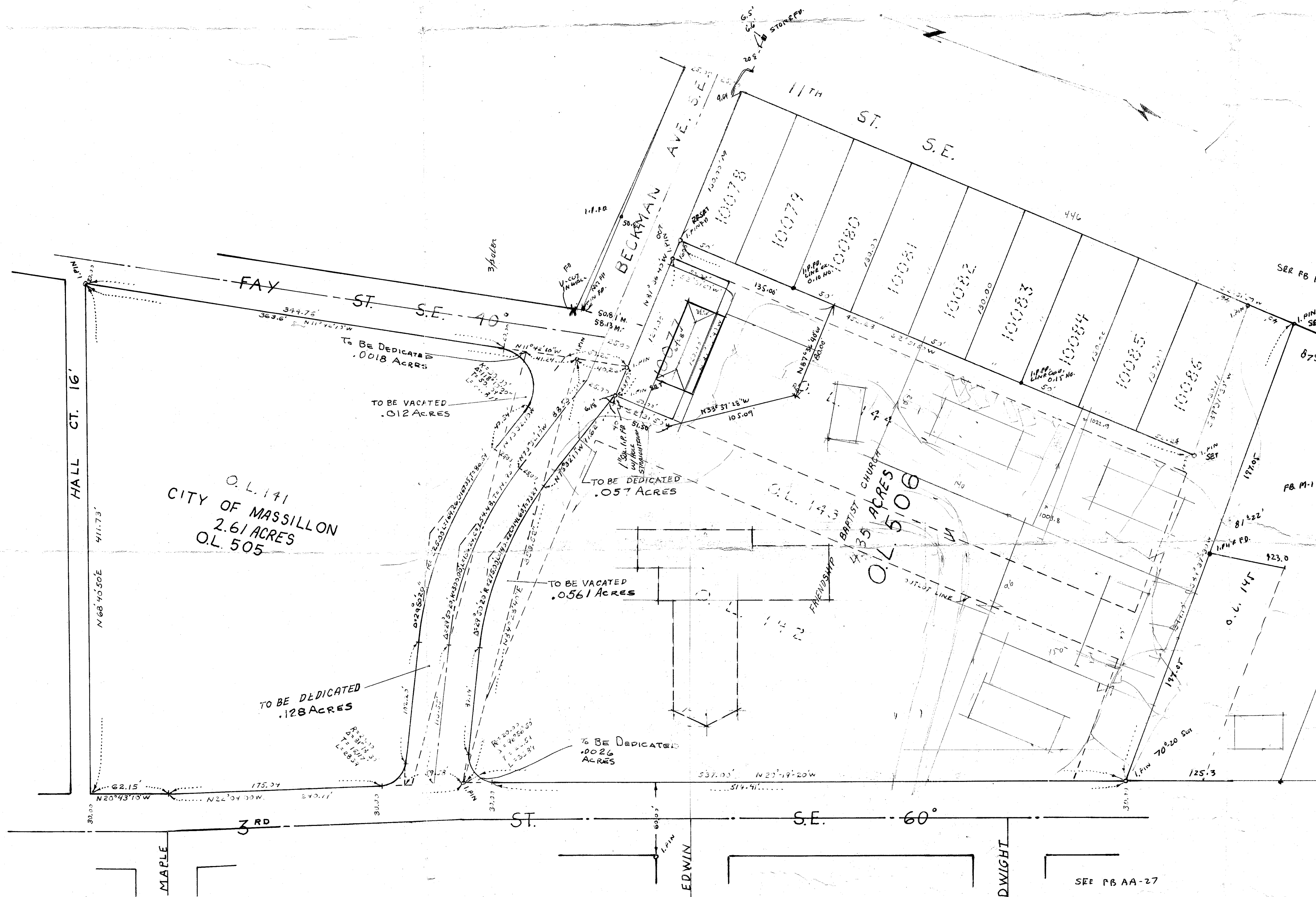




BECKMAN AVE. S.E. 50'
