

GENERAL NOTES


- 4. ALL MATERIALS 301,404, CONC. ETC. AND METHODS OF APPLICATION, CONSTRUCTION ETC., USED ON THIS JOB MUST MEET THE LATEST STATE OF OHIO, DEPT. OF HIGHWAYS SPECIFICATIONS. CHARLED STATE OF THE ENGINEER, CONTRACTOR IS TO FURNISH ALL NECESSARY CYLINDERS FOR TESTS AND TO PROVIDE ADEQUATE STORAGE OF TEST CONES UNTIL TAKEN TO TESTING LABORATORY BY CONTRACTOR, TESTS TO BE PAID BY CONTRACTOR.
- AND SEARCHES OF AVAILABLE RECORDS. IT IS BELIEVED THAT THEY ARE ESSENTIALLY CORRECT, BUT THE CITY OF MASSILLON DOES NOT GUARANTEE THEIR ACCURACY OR COMPLETENESS.

 7. TRAFFIC MAINTENANCE AT ALL TIMES, ONE LANE OF TRAFFIC IN EACH DIRECTION ON LINCOLN WAY
- 8 FIRE DEPT. MUST BE NOTIFIED EACH TIME, TRAFFIC IS DETOURED.
- 9. ESTIMATED QUANTITIES, SPECIFIC LOCATIONS AND USAGE OF ESTIMATED QUANTITIES SET UP ON THESE PLANS TO BE USED "AS DIRECTED BY THE ENGINEER" SHALL BE MADE A MATTER OF RECORD BY INCORPORATION INTO THE FINAL CHANGE ORDER GOVERNING COMPLETION OF THIS PROJECT.
- 10. SEEDING, THE QUANTITIES FOR SEEDING ARE CALCULATED FOR THE SOIL AREAS BETWEEN LINES THREE (3) FEET OUTSIDE THE WORK LIMITS, OR THE RIGHT-OF-WAY LINE IF SUCH LINE IS LESS THAN THREE (3) FEET FROM THE WORK LIMITS.
- CONNECTION TO EXISTING PIPE AT PLACES WHERE THE PLANS PROVIDE FOR PROPOSED PIPE TO BE CONNECTED TO EXISTING PIPE, IT SHALL BE THE RESPONSIBILITY OF THE CONTRACTOR TO LOCATE THE EXISTING PIPE BOTH AS TO LINE AND GRADE BEFORE HE STARTS TO LAY THE PROPOSED PIPE. THE COST OF THIS OPERATION SHALL BE INCLUDED IN THE UNIT PRICE BID FOR THE PERTINENT CONDUIT ITEM.
