WHEREAS, the City of Massillon and Stark County entered into a sewer service agreement on November 19, 1981, the First Supplemental Agreement on May 11, 1983, the Second Supplemental on October 4, 1984, the Third Supplemental on April 4, 1990, the Fourth Supplemental on October 29, 1993, the Fifth Supplemental on November 30, 1995, the Sixth Supplemental on June 25, 1996, and the Seventh Supplemental on October 8, 1996, said Agreements referred to as the Basic Agreement; and

WHEREAS, the City has found it necessary to rehabilitate two primary clarifiers and replace components of the sludge pump building number 2 and modify the plant's disinfection and dechlorination processes; and

WHEREAS, the City and the County desire to update the joint sewerage system facilities plan which was initially commissioned in the mid 1970's and as part of the plan update, a number of points in the joint system will be metered to determine amounts of infiltration/inflow so that information can be utilized in evaluating solutions to system surcharging problems; and

WHEREAS, the County, acting under authority of Revised Code Section 6117.01 et. seq., and Massillon, acting pursuant to Article XVIII of the Ohio Constitution, are fully authorized to enter into this Agreement; and

WHEREAS, the same terms used herein have the definitions as described in the Basic Agreement:

NOW, THEREFORE, in consideration of the premises and of the mutual covenants hereinafter set forth, and of other good and valuable considerations, the County and Massillon do hereby agree to amend the Basic Agreement as follows:

Section 1.0

The Primary Clarifier and Disinfection Improvements project includes the replacement of Primary Clarifier 7 and 8 equipment, selected valves, outdoor lighting, walkway and handrail, Primary Sludge Building No. 2 pumps, selected valves, piping and roof, including electrical, heating and ventilation work, all of which were constructed in 1962 and require rehabilitation. Gaseous chlorine will be replaced with liquid chlorine through construction of a Disinfection/ Dechlorination metal building, storage tanks, metering pumps, secondary containment, chlorine contact tank modifications including electrical, heating, and ventilation work.

The estimated project cost for this project including engineering and construction is \$975,000.00.

1.02 The Massillon-Stark County, Ohio Regional Sewerage System Facilities Plan update project includes sanitary sewer flow monitoring of up to twenty-five (25) locations in the City and County systems for a period of 120 days to determine dry weather and wet weather flows due to infiltration and inflow (I/I) and the updating of the 1976 Facilities Plan to provide the planning necessary to determine wastewater treatment plant and trunk sewer system capacity needs for Massillon and Stark County for the next twenty (20) years.

The estimated cost of sewer system flow monitoring, I/I analyses, and the Facility Plan Update is \$150,000.00.

- .03 Based on computed cost sharing information included in Section 1.03 of the Fourth Supplemental Agreement, the County shall pay a share of 51% as invoiced monthly by the City during the course of construction of the wastewater treatment plant improvements and the implementation of the Facilities Plan Update project. Said share amounts to \$573,750.00 based on estimated project costs.
- 1.04 Upon completion of the projects by Massillon, the City shall provide the County with final costs and the County's share shall be adjusted accordingly.

Except as amended hereby, the Basic Agreement is hereby confirmed in all other respects.

This Agreement includes the exhibits attached hereto, all of which are fully a part of this Agreement as if herein fully set forth in writing.

Proposed Bicycle Licensing Program

Submitted by Chief Mark Weldon April 10th, 1997

In the last two years the Massillon Police Department has seen a dramatic increase in the number of recovered bicycles for which no owner can be located. These bicycles can only be disposed of at the annual public auction, which creates a major administrative burden. In previous years we auctioned 40 to 60 bikes. Last year the number was 140, and this year we expect the number to be in excess of 160. We do not have enough buyers at the auction for all these bikes. Having this many bikes also creates a major storage problem.

We also have a tremendous number of bicycles stolen every year, and in most cases the owner does not have the necessary information to positively identify the stolen bike.

To try to alleviate both problems, I am proposing to revamp and revitalize our system for registering and licensing bicycles. Most people are unaware that Massillon City Ordinances require bicycles to be licensed. This has been the law since the 1950's. It is a law that has not been enforced as long as I have been a member of the department. The procedure is inconvenient for citizens, and the license plate itself is not suitable for modern bikes.

My proposal involves the following major components:

- 1. Replace the current metal license plate with a metallic foil license sticker.
- 2. Make the registration and licensing process available through bicycle retailers. Ernie's, Hill's and K-Mart have agreed to participate. This will be more convenient for citizens due the stores having longer business hours than City Hall.
- 3. Increase the license fee from \$.50 to \$2.00. Retailers will be permitted to keep \$.50 for each license they sell.
- 4. Education and active enforcement of the licensing ordinance to increase compliance.

ORDINANCE CHANGES

The revamping of the registration and licensing will require making changes to Chapter 373 of the Codified Ordinances of the City of Massillon. The current version of the ordinances that follow should be repealed and replaced with the language contained here.

373.13 Information Required; Minors

Every owner of a bicycle having a wheel diameter of twenty (20) inches or greater shall register with the Chief of Police his or her name, address, phone number, the name of the manufacturer, model name or number, serial number, style, color(s) and general description. In the event the owner of the bicycle is a minor under the age of eighteen years, then the parent or guardian or the person having the care of such minor shall make such registration on behalf of the minor."

373.14 Registration Forms & Stickers; Agents; Display

- (a) The Chief of Police shall provide sequentially numbered registration stickers suitable for affixing to the frame of a bicycle, and forms for the recording and registration of the sticker number and information required under Ordinance 373.13.
- (b) Any person or company engaged in the business of selling bicycles at retail within the City of Massillon may be authorized to act as an agent for the purpose of registering and licensing bicycles. Such agents shall comply with licensing and registration procedures as established by the Chief of Police. An agent shall be entitled to retain fifty cents (\$.50) of the licensing fee for each bicycle licensed and registered.
- (c) Any resident of the City of Massillon acquiring ownership of a bicycle having a wheel diameter of twenty (20) inches or greater shall register the bicyle pursuant to this chapter within five (5) days of the date of acquisition. For bicycles having a wheel diameter of less than twenty (20) inches registration is optional.
- (d) Upon completion of the registration form and payment of the registration fee, the owner shall receive a numbered registration sticker and copy of the registration form. The numbered registration sticker shall be affixed to the bicycle frame in a conspicuous place.

373.15 Sale and Transfer

It shall be the duty of any person who sells or transfers ownership of any bicycle to report such sale or transfer to the Massillon Police Department. It shall be the duty of the purchaser or transferee of such bicycle to register the bicycle and obtain a registration sticker pursuant to Ordinance 373.14(a).

373.16 Dismantling Bicycles

Any person who dismantles, reduces to junk or takes out of operation any bicycle bearing a registration sticker issued by the City of Massillon shall report the same to the Massillon Police Department.

373.17 Tampering With Numbers On Bicycle

- (a) No person shall purposely or knowingly remove, destroy, mutilate or alter the numbers on any bicycle frame.
- (b) No person shall purposely or knowingly remove destroy, mutilate or alter any registration sticker or license tag or make any facsimile of a license tag or registration sticker. This section does not apply to the legal owner of the bicycle or licensing agent who has removed the sticker of a previous owner pursuant to re-registering the bicycle.

373.18 Loss of Registration Sticker

In case of the loss or destruction of a registration sticker, the registered owner shall obtain a replacement sticker upon satisfactory proof of the loss or destruction to the Massillon Police Department. Replacement registration stickers may only be obtained at the Massillon Police Department.

373.19 Fees

The fee for the registration and licensing of each bicycle shall be two dollars (\$2.00) and shall be paid to the Massillon Police Department or designated retail agent at the time of registration. The fee for a registration sticker to replace one lost or destroyed pursuant to Ordinance 373.18 shall be one dollar (\$1.00).

373.20 Inspection

No bicycle may be registered or licensed unless it is physically presented to and inspected by an officer of the Massillon Police Department or the person issuing the registration sticker. Registration may be denied if the bicycle is found not to be in safe operating condition.

373.22 Impounding

If the operator of any bicycle violates any of the provisions of this chapter, such bicycle may be immediately taken and impounded by the Massillon Police Department for a period to be determined by the Chief of Police or an officer appointed by him, but not to exceed ten (10) days. If any bicycle is found unattended, the Police Department shall take possession of such bicycle and hold it until ownership can be established. Bicycles for which no owner can be found shall be disposed of in accordance with the law.





ORDINANCE NO. 92 - 1997

BY: COMMUNITY DEVELOPMENT AND ANNEXATION COMMITTEE

TITLE: AN ORDINANCE indicating what services the City of Massillon, Ohio, will provide to the Richville Drive-Nave Street Area Annexation, upon annexation, and declaring an emergency.

WHEREAS, certain property owners have filed a petition requesting the Richville Drive-Nave Street Area Annexation to be annexed to the City of Massillon, Ohio, pursuant to the Ohio Revised Code Section 709.02, and

WHEREAS, The Ohio Revised Code Section 709.031 (B) requires:

Upon receiving this notice, the Municipal Legislative Authority, hall by Ordinance or Resolution, adopt a statement indicating what services, if any, the municipal corporation will provide to the territory proposed for annexation upon annexation,

and

WHEREAS, this Ordinance is intended to comply with the requirements of the Ohio Revised Code Section $709.031\ (B)$, and

WHEREAS, the legislative authority of the City of Massillon, Ohio, is supportive of the annexation proposal, and

WHEREAS, the Stark County Commissioners have scheduled a public hearing, to be held in the Perry Township Hall, at 3111 Hilton Street N.W. on Wednesday, May 21, 1997 at 7:00 P.M.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section 1:

The City of Massillon, Ohio, will extend to the proposed area, upon annexation, the availability of all municipal services extended to all of the current citizens, residents and property owners of the City of Massillon, Ohio, including, but not limited, to the services of the Municipal Police Department, services of the Municipal Fire Department, services of the Municipal Service Department, services of the Engineering Department, services of the Building Department, services of the Street Department, services of the Safety Department, services of the Planning Department, services of the Health Department, services of the Sewer Department and services of the City of Massillon Administration.

The City of Massillon, Ohio, will extend a trunkline sewer to the perimeter of the Nova East development at a location to be determined by the developer of the Nova East development at no cost to the developer of the Nova East development. The developer of the Nova East development shall consult with the City of Massillon, Ohio, Engineering Department to determine the location of the sewer to be most economical to the City of Massillon, Ohio, and to adequately serve the Nova East development. The final location of the point of intersection of the sewer with the perimeter of the Nova East development shall be communicated in writing by the developer of the Nova East development to the Massillon City Engineer no later than May 1, 1997. The City of Massillon, Ohio,

will use its expedited efforts to design the sewer extension and submit to the Ohio EPA, no later than May 31, 1997, the necessary information to secure the approval for construction of the sewer. Construction of the sewer will commence by the issuance to the sewer construction contractor of an authority to proceed notice no later than July 31, 1997.

The City of Massillon, Ohio, will extend "enterprise zone" classification to the development and provide a 75% abatement of real and personal property taxes for 10 years. The legislative authority of the City of Massillon, Ohio, will introduce legislation for the expansion of the enterprise zone and the tax abatement within thirty days following the acceptance of the annexation by the legislative authority of the City of Massillon, Ohio, said thirty days extended by the State of Ohio approval and notification process. It is the duty of the developer of the Nova East development to apply for the enterprise zone designation and the abatement.

The City of Massillon, Ohio, will use its best efforts to secure or assist the developer of the Nova East development and the owners of land within the Nova East development in securing grants, loans and development assistance (including infrastructure development) as available to the development.

The City of Massillon, Ohio, will install at no cost to the developer of the Nova East development street lighting on Richville Drive by August 1, 1997. The operational cost of underground-wired ornamental street lighting on all dedicated public streets within the Nova East development will be the responsibility of the City of Massillon.

The City of Massillon, Ohio, will assist in securing the approval of the Ohio Department of Transportation for an intersection of the Nova East development streets with Richville Drive.

The City of Massillon, Ohio, will approve a variance on the length and configuration of the streets within the Nova East development. Specifically, the length to the cul-de-sac and the block length requirements will be subject to variance.

The City of Massillon, Ohio, will designate the zoning in the Nova East development as "Light Industrial" as set forth in Chapter 1169 of the Codified Ordinances of the City of Massillon. The Nova East development shall retain the zoning classification as designated by Perry Township until rezoned by the City of Massillon, Ohio. If the Nova East development is zoned any classification other than Light Industrial under the Perry Township Zoning Code, the developer of the Nova East development shall submit a written rezoning request within thirty days following the acceptance of the annexation by the legislative authority of the City of Massillon, Ohio. The City of Massillon, Ohio, shall expedite the rezoning of the Nova East development in the shortest period allowed under law.

Section 2:

That this Ordinance is hereby adopted and shall be immediately effective. Further, this ordinance shall be considered as an official statement of the Council of the City of Massillon, Ohio.
