AMENDMENT TO OHIO ENTERPRISE ZONE AGREEMENT

This Amendment is made and entered into by and between the CITY OF MASSILLON, OHIO, a Municipal Corporation (hereinafter "City of Massillon") and RAYCO MANUFACTURING, INC., an Ohio Corporation (hereinafter "Rayco Manufacturing")

WITNESSETH: -

WHEREAS, the City of Massillon and Rayco Manufacturing have previously entered into an Ohio Enterprise Zone Agreement dated September 25, 2000 (hereinafter "Agreement"); and

Whereas, pursuant to the Agreement, Rayco Manufacturing, a manufacturer of stump cutter machines and forestry mowing equipment, agreed to establish a facility within the Enterprise Zone through the construction of a new facility that will house the company's manufacturing operations, (hereinafter the "Project"); and

Whereas, pursuant to the Agreement, Rayco Manufacturing agreed to undertake the Project in two phases: Phase 1 being the construction of a new 84,350 square foot industrial building including the purchase and installation of new machinery and equipment; and Phase 2 being the construction of a new 115,500 square foot addition and the purchase and installation of additional machinery and equipment to provide increased manufacturing and warehouse capacity.

WHEREAS, pursuant to the Agreement, the City of Massillon agreed to grant Rayco Manufacturing a tax exemption pursuant to ORC 5709.62 for eligible real and personal property improvements in conjunction with the Project; and

WHEREAS, pursuant to the Agreement, Rayco Manufacturing agreed to complete Phase 1 of the Project by June 30, 2001; and

WHEREAS, due to circumstances beyond its control, Rayco Manufacturing will not be able to complete Phase 1 of the Project by June 30, 2001 and has requested that this completion date be extended through December 31, 2001; and

WHEREAS, in order to accomplish the intended purpose of the Agreement, the Parties have determined to amend the Agreement, in the particulars set forth herein.

NOW, THEREFORE, in consideration of the mutual covenants set forth in the Agreement and the benefit to be derived from each party for completion of Phase 1 of the Project as contemplated by the Agreement, the parties hereby agree as follows:

1. Section 1, paragraph 5 of the Agreement is hereby amended to read as follows: "Phase 1 will begin in September 2000 and all acquisition, construction, and installation under this phase of the Project will be completed by December 31, 2001." 2. In all other respects, the Agreement is hereby confirmed and ratified as written. RESOLUTION NO. 14-2001

BY: COMMUNITY DEVELOPMENT & ANNEXATION COMMITTEE

TITLE: A RESOLUTION declaring the intention of the City of Massillon, Ohio to appropriate property within the corporate limits pursuant to the authority in CHAPTER 719 of the Ohio Revised Code, and declaring the necessity to acquire property for the purpose of redevelopment.

WHEREAS, it is necessary to acquire property within the corporate limits of the City of Massillon for the reason that the city is an "impacted city," as defined in division (C) of Section 1728.01 of the Ohio Revised Code, and the acquisition of such property is necessary in order to create or preserve jobs and employment opportunities and to improve the economic welfare of the people of the City of Massillon; and

WHEREAS, the City of Massillon intends to appropriate, enter upon, and hold such property within its corporate limits for either (a) the sale, lease, exchange or other disposition of such property for use or development for industry, commerce, housing, distribution, or research; or (b) the construction, enlargement, improvement, or equipment and subsequent sale, lease, exchange, r other disposition of such property with the structures, equipment, and facilities thereon for industry, commerce, housing, distribution, or research; and

WHEREAS, the property to be acquired is part of an Urban Renewal Plan which has been adopted by the City of Massillon, and

WHEREAS, it is desirable in the public interest that the City take possession of the property and the structures thereon, and

WHEREAS, the City, prior to the actual filing of a complaint will attempt to purchase the property from the landowners.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section I:

It is deemed necessary and it is hereby declared to be the intention of this Council to acquire the following described property:

"Situated in the City of Massillon, County of Stark and State of Ohio and known as Part of Out Lot No. 13, a .33 acre parcel, the address being 217 Third Street N.W., according to the present numbering of lots therein."

Section 2:

The property hereinabove described is to be acquired pursuant to an Urban Renewal Plan which has been adopted by the City and is therefore declared to be desirable in the public interest that the City take possession by all legal means including eminent domain of the desired property and the structures thereon. Said redevelopment is vital for the future development of the City of Massillon.

Section 3:

The Mayor is hereby authorized to cause written notice of the passage of this Resolution to be given to the owner, persons in possession or having an interest of record in the above premises and said notice shall be served according to law by the person designated for that purpose and to make return of said service of notice in the manner provided by law.

Section 4:

This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health or safety of the citizens of the City of Massillon, the emergency being to proceed with the rehabilitation and subsequent sale of the within property, and rovided it received the affirmative vote of two-thirds of all the members duly elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
