RESOLUTION NO. 23 - 2003

BY: COMMITTEE OF THE WHOLE

TITLE: A RESOLUTION opposing the Free Trade Area of Americas and authorizing the Mayor to communicate the City's position to the U.S. Trade Representative, State Legislative and Congressional committees with trade jurisdiction; and declaring an emergency.

WHEREAS, the Free Trade Area of the Americas (FTAA) would be essentially an extension of the North American Free Trade Agreement (NAFTA) to the entire western hemisphere; and

WHEREAS, the nogiatins surrounding the FTAA have been held secretly, without allowing for any effective public evaluation or input; and

WHEREAS, NAFTA's Chapter 11 provision for Investor to State Lawsuits, which will be included and strengthened in the FTAA, directly threatens the sovereignty of local an state governments; and

WHEREAS, this sort of corporate power would diminish the efficiency of local environmental laws and regulations, and make government bodies at every level reluctant to risk enacting desireable legislation for fear of such suits; and

WHEREAS, the FTAA agreement may lead to the privatization of public resources, including water, throughout the hemisphere without public discussion of the desirability of this; and

WHEREAS, the FTAA agreement will undermine the social services that are essential for a thriving community; and

WHEREAS, the strict intellectual property laws within the FTAA will have devastating impacts on the people living in the global south; and

WHEREAS, the FTAA agreements provides no protections for the rights of labor to organize for collective bargaining; and

WHEREAS, local businesses and workers would be harmed by the increasing powers granted to large corporations; and

WHEREAS, local resolutions like this one have been instrumental in defeating other destructive trade agreements such as the Multilateral Agreement on Investment (MAI), NOW, THEREFORE,

Be is resolved by the Council of the City of Massillon:

Section 1:

Is in direct opposition to the proposed Free Trade Area of the Americas.

Section 2:

Petitions the federal government to refuse to sign any new trade and investment agreements, such as the proposed Free Trade Area of the Americas, that include investor-state provisions similar to the ones included in NAFTA.

Section 3:

Urges the U.S. Trade Representatives to withdraw from any further negotiation on the FTAA.

Section 4:

Requests the U.S. Trade Representatives to release their proposals for the agreement, their itten submissions to the nine negotiating groups of the FTAA, and a comprehensive list of the presentatives to the FTAA negotiating groups from all 34 countries involved.

Section 5:

Urges the U.S. Congress to adopt stronger sovereignty safeguards in implementing legislation for the FTAA and other trade agreements, now and in the future.

Section 6:

The Mayor of the City of Massillon will forward this resolution to the President of the United States, the U.S. Trade Representative, to members of the House of Representatives representing the City of Massillon, to the U.S. Senators from Ohio, and to the Congressional committees with trade jurisdiction, and be made known to the people of Massillon.

Section 7:

That this resolution hereby is declared to be an emergency and shall be in force and effect from and after its adoption. The reason for the emergency lies in the fact that the same is necessary for the immediate preservation of the public peace, health, safety and property, and for the further reason that time is of the essence in making this request to our federal legislators and the President of the Linted States.
