## Section 1:

Ordinance No. 51 - 2004 be and is hereby repealed.

## Section 2:

The Council of the City of Massillon, Ohio, hereby finds that it is necessary to enter into a contract, without competitive bidding, with Republic Services of Ohio, LLC, dba Countywide Recycling 7 Disposal Facility for the disposal of municipal solid waste for the City of Massillon, Ohio.

## Section 3:

The Director of Public Service and Safety of the City of Massillon, Ohio, is hereby authorized and directed to enter into the contract attached hereto as Exhibit "A", without competitive bidding, with Republic Services of Ohio, LLC, dba Countywide Recycling & Disposal Facility for the disposal of municipal solid waste for the City of Massillon, Ohio.

# Section 4:

Said agreement is an extension of the original agreement for a two-year period. The cost mains the same at a total of Fourteen Dollars and Thirty-Four cents (\$14.34) plus host fees per ton through the remainder of the original term July 23, 2004 and will then be reduced to Twelve Dollars and Seventy-Five cents (\$12.75) per ton plus host fees for the extended term of July 24, 2004 through July 23, 2006.

## Section 5:

This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety and welfare of the community, and for the additional reason that it is necessary to enter into the extension of the original contract to receive reduced rates during the extension and to implement the new fees for the disposal of municipal solid waste for the City of Massillon. Provided it receives the affirmative vote of two-thirds of the elected members to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

# FIRST AMENDMENT TO DISPOSAL AGREEMENT

This First Amendment dated this \_\_\_\_ day of February, 2004, hereby amends the Disposal Agreement dated July 26, 2001 (the "Agreement"), by and between Republic Services of Ohio, LLC, d/b/a/ Countywide RDF, a limited liability company organized and existing under the laws of the State of Ohio ("Republic") and the City of Massillon, a corporation organized and existing under the laws of the State of Ohio ("Customer").

#### RECITALS

It is hereby ascertained, determined and declared by the parties that:

- A. In consideration of the mutual covenants contained herein, the Customer desires to extend the term of the Agreement as set forth herein;
- B. In consideration of the Customer's agreement to extend the term, Republic desires to offer the economic incentives set forth herein.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by each of the parties to this Amendment, the parties agree as follows:

- 1. The term of the Agreement is hereby extended for an additional two (2) years through midnight Ohio Time, on July 23, 2006.
- 2. The Customer is currently paying the Republic the disposal rate of \$14.34 per ton for the disposal of Solid Waste (as defined in the Agreement). The new disposal rate for the term of this extension will be \$12.75 per ton plus fees.
- 3. Republic agrees to forego its annual Consumer Price Index disposal rate adjustment rights pursuant to paragraph 6. (d) of the Agreement through the remainder of the term, or through July 23, 2006.
- 4. Except as expressly set forth herein, the remaining terms and conditions of the Agreement shall remain in full force and effect and unaffected by this Amendment.
