1501.12 CONFLICT

- (a) Where there is a conflict between the Ohio Fire Code and the rules and regulations of City of Massillon Codified Ordinances, the requirements which provide the greatest safety shall be applied. (OAC) 1301:7-1-02(G).
- (b) In addition the Massillon Law Department shall check the remaining Sections of the Fire Prevention Code to update items as needed.

Section 3:

This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the health, safety and welfare of the community and for the additional reason that it is necessary that these revision be made to the codified ordinances for the efficient operation of the Massillon Fire Department. Provided it receives the affirmative vote of two-thirds of the elected members to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section 1:

The Council of the City of Massillon, Ohio, deems it necessary and in the best interest of the City to enter into a settlement agreement with Massillon and Perry Township Schools concerning the above referenced litigation.

Section 2:

As full and final Settlement of the above referenced litigation the Council of the City of Massillon, Ohio authorizes the Mayor and the Director of Public Service and Safety to enter into a settlement agreement with Massillon and Perry Township School Districts which essentially provides for the payment of approximately \$414,851.00 to the school districts over a two and one half year period.

Section 3:

In exchange for these payments being made both the City and the School Districts will dismiss all claims with prejudice in the above referenced case.

Section 4:

This Resolution is declared to be an emergency measure so that a decision can be made with regard to the proposed settlement on or before November 22, 2005 as the mediation agreement requires approval by both the City Council and the Massillon and Perry Boards of Education on or before such date. Wherefore, this Resolution shall be in full force and effect immediately from and after passage and approval by the Mayor.

ORDINANCE NO. 117 - 2005

BY: COMMUNITY DEVELOPMENT COMMITTEE

TITLE: AN ORDINANCE amending Section 1151.02 of the Massillon Code of 1985 rezoning a certain tract of land from I-1 Light Industrial to RM-1 Multiple Family Residential and R-CRD Condominium Residential District.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section I:

It is hereby determined to be in the best interest and promotion of the general health, safety and convenience, comfort, prosperity and welfare of the community to change the designation of the area set forth in Section 2 hereof from I-1 Light Industrial to RM-I Multiple Family Residential and R-CRD Condominium Residential District. Said rezoning was approved by the Planning Commission of the City of Massillon, Ohio, on October 12, 2005 and that notice and public hearing has been given according to law.

Section 2:

The City of Massillon, Ohio, Zone Map as identified by Section 1151.02 of the Massillon Code of 1985, be and is hereby amended to show the following described area as RM-1 Multiple Family Residential and R-CRD Condominium Residential District.

Being known as a 39.93 acre vacant tract of land located on the south side of Cherry Road NW, between 5th Street NW and 17th Street NW, and consisting of Out Lots 93, 94 and Part of Out Lot 91. The applicant wants to construct 14 4-unit condominium buildings, 31 attached town house senior apartments, and a 96 room independent living facility. The applicant is Ben Grisez Homes, Inc.

Section 3:

This ordinance shall take effect and be in force from and after the earliest period allowed by law.
