NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

## Section I:

The Council of the City of Massillon, Ohio, hereby determines it to be necessary and in the public health, safety and welfare to authorize the Director of Public Service and Safety of the City of Massillon, Ohio, to submit an application for 2011 Municipal Road Funds for the Carmont Avenue/17<sup>th</sup> Street Resurfacing and 9<sup>th</sup> Street SW Resurfacing.

## Section 2:

The Director of Public Service and Safety of the City of Massillon, Ohio, is hereby authorized and directed to submit an application for 2011 Municipal Road Funds Resurfacing. The breakdown of funds for the project is as follows:

SCATS Massillon Share \$ 4,473.00 Carmont Avenue/17<sup>th</sup> Street Resurfacing \$105,000.00 9<sup>th</sup> Street SW Resurfacing \$109,000.00

## Section 3:

This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the health, safety and welfare of the community and for the additional reason that it is necessary to submit the Carmont Avenue/17<sup>th</sup> Street Resurfacing and the 9<sup>th</sup> Street SW Resurfacing Projects in order to receive the 2011 Municipal Road Funds. Provided it receives the affirmative vote of two-thirds of the elected members to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
