Now, therefore be it resolved the Massillon City Council, County of Stark, Ohio that:

Section 1:

That Massillon City Council hereby authorizes and directs the submission to the electors of the City of Massillon, Ohio, at a general election to be held at the usual places of voting in the City of Massillon on Tuesday, November 8, 2011 between the hours established by the Board of Elections the question of approving the passage of a two-tenths percent (.20%) increase to the income tax levied on salaries, wages, commissions and other compensation and on net profits as set forth in Massillon Codified Ordinances to be effective January 1, 2012 and continuing thereafter.

Section 2:

That it is the desire of Massillon City Council that the ballots presented to the electors of the City of Massillon, Stark County, Ohio shall be in substantially the following form:
