NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section I:

The Council of the City of Massillon, Ohio, hereby determines it to be necessary in the public health, safety and welfare to enter into a sixty (60) day extension of said contract with the Board of Trustees of Jackson Township for the purpose of EMS Transport billing.

Section 2:

The Director of Public Service and Safety of the City of Massillon, Ohio, is hereby authorized and directed to enter into a sixty (60) day extension of said contract with the Board of Trustees of Jackson Township for the purpose of EMS Transport billing. The said contract is attached hereto as Exhibit "A".

Section 3:

This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the health, safety and welfare of the community and for the additional reason that it is necessary to extend the EMS Transport billing contract with the Board of Trustees of Jackson Township for an additional sixty (60) days for EMS Transporting that will be performed by the Massillon Fire Department. Provided it receives the affirmative vote of two-thirds of the elected members to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

EMS Charges Billing Agreement

The following is an Agreement between the Board of Trustees of Jackson Township, Stark County, Ohio (Jackson Township), and the City of Massillon, Stark County, Ohio (Massillon).

Jackson Township agrees to:

- 1. Process and mail insurance claims by generating a computerized HCFA-1500 form. This includes all commercial insurance, Medicaid, UMWA, Worker's Compensation and Medicare supplemental policies.
- 2. Manage accounts receivable for up to 120 days. After that time, Jackson Township will submit these accounts to Massillon's designated collection agency.
- 3. Provide all insurance forms, postage and billing supplies.
- Maintain hard copy files for audit purposes.
- 5. Stay current with insurance changes, billing technique improvements, Medicare updates and all HIPAA compliancy regulations.
- 6. Provide your department with a monthly report that will show what was billed, to whom, what dollar amount and how many claims were submitted.
- 7. Reprocess any claims denied due to processing errors, coding, patient information at no extra charge.
- 8. Respect the confidentiality of your records by providing secure and password protected measures and require all staff to sign confidentiality agreements.

Massillon agrees to:

- 1. Collect all necessary patient and insurance information. This will include the authorization signature (HIPAA Privacy Act) for submission to patient's insurance.
- 2. Massillon will be billed every two months.
- 3. Pay invoices by the 15th of the month after invoice received.
- 4. Forward all copies of patient payments along with EOB's to Jackson Township.
- 5. Pay \$12 for each run processed by Jackson Township.

Conditions:

- 1. This Agreement will be binding for a period of one (1) year commencing January 1, 2011.
- 2. Amendments to this Agreement will be accepted if signed by both parties.

- 3. Jackson Township reserves the right to discontinue all services if its invoices are not paid in full by the 15th of the month after an invoice is received. A late fee of \$50.00 may be incurred on all past due invoices.
- 4. This Agreement may be terminated after a 30 day written notice by either party.

Legislation Request: Jail Transportation Agreements

I have recently completed calculations of the Jail Transportation Fees for calendar year 2012, I sent them to all participating jurisdictions for review. I have received one approved contract. There not been advised of any objections or problems with the contracts. The language is the same as last year, only the dollar amounts have changed.

I would request that you submit a legislation request to Massillon City Council for approval of the Jail Transportation Contracts as shown in the attachment. The fees are as

follows:

In addition to the above contracted amounts, there is a provision in the contract for each participating department to pay the Massillon Police Department a twenty dollar fee for fingerprinting their prisoners. I would request a separate line-item or account be set up to receive these monies. Furthermore, I would request that these monies be restricted to pay for improvements to the Massillon City Jail. These monies should amount to less than \$10,000.00 per year.

2. Warrant Service:

In the event an Agency makes an arrest upon a Warrant, and the Warrant is not a Warrant issued by the Massillon Police Department, the arresting Agency shall be responsible for transportation of said prisoner to the Stark County Jail for booking. In the event the Agency makes an arrest upon a Massillon Police Department Warrant, the arresting Agency may drop the prisoner off at the Massillon Police Department or make arrangements to meet at a mutually acceptable location to turn the arrestee over to the Massillon Police Department for transportation and booking.

3. Reportable Offenses:

When an Arresting Agency chooses to summons, rather than book a person charged with a reportable offense, and the person is sent to MPD for processing, the Agency will be charged a fee of \$20.00 per processing.

- 4. The annual amounts to be paid by each Agency in 2012 shall be computed by allocating the actual costs incurred and number of prisoners actually transported in 2011 for each Agency, said calculation to be provided to each Agency on or before January 30, 2012.
- Additional Provisions:

Massillon further agrees to provide the following:

- A. Routine medical attention that may be required and can be provided at the Massillon City Jail:
- B. Transportation to a hospital emergency room or other local clinic in cases where medical attention other than routine is required and such transportation can be safely and properly provided in a police department vehicle;
- A guard for the prisoner while at the hospital for a period not to exceed three (3) hours, provided that no overtime costs are incurred to supply the guard;
- 6. In consideration of the foregoing, Agency covenants and agrees to pay Massillon the following:
 - A. The total cost of using a Massillon police officer to serve as a guard while the Agency prisoner is confined to a hospital, except as provided in section (2) above. A minimum of two (2) hours will be charged in the event that a hospital guard is required. Such costs shall include any overtime costs or other payroll costs associated with supplying a guard officer. Agency shall be given notice and an opportunity to supply personnel of its own law enforcement agency to serve as a guard while the prisoner is confined in a hospital. Massillon police officer shall serve only as a guard after Agency has been given notice and failed to supply a guard pursuant to this section.

B. It is understood that individual prisoners are primarily responsible for all costs of medical treatment or special medicines required in their treatment. Agency agrees to assume responsibility for any medical costs for which an Agency prisoner cannot be held responsible. In the event that Massillon is adjudicated liable for costs incurred by a Agency prisoner, Agency shall reimburse Massillon for said amount. However, Agency shall not be responsible for payment of the above costs of special medicines, medical attention or burial costs where the cause of death of the cause of illness or injury requiring medical attention or the administration of special medicines was the result of malfeasance, nonfeasance, neglect of duty or any other action of an employee and/or police officer of Massillon.

This Agreement shall take effect in January 1, 2012, and remain in effect until December 31, 2012, unless superseded or rescinded, however, either party may terminate this agreement upon thirty (30) days written notice to the other party.

This Agreement constitutes the entire agreement between Massillon and Perry Township. All other agreements concerning the booking and handling of prisoners, whether written or verbal, are hereby rescinded. Nothing in the Agreement shall be construed to provide any agreement, benefit or cause of action to any third party.
