TITLE: AN ORDINANCE authorizing the Director of Public Service and Safety of the City of Massillon, Ohio, to sign the grant agreement with the Ohio Public Works Commission for the Erie Street South Repair Project, and declaring an emergency.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO. THAT:

## Section 1:

The Council of the City of Massillon, Ohio, hereby determines it to be necessary in the public health, safety and welfare to sign the grant agreement with the Ohio Public Works Commission for the Erie Street South Repair Project.

## Section 2:

The Director of Public Service and Safety of the City of Massillon, Ohio, is hereby authorized to sign the grant agreement with the Ohio Public Works Commission for the Erie Street South Repair Project. The City has been awarded a One Hundred Six Thousand Four Hundred Seventy-Five Dollar (\$106,475.00) grant which will be used for the Erie Street South Repair Project. This is a 90/10 split which the City will be responsible for Eleven Thousand Eight Hundred Thirty Dollars (\$11,830.00).

## Section 3:

This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety, and welfare of the community, and for the reason that the dollars received from the Ohio Public Works Commission will pay towards the Erie Street South Repair Project. Provided it receives the affirmative vote of two-thirds of the elected members to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
