TITLE: AN ORDINANCE amending CHAPTER 1185 "FLOOD PLAIN AREAS" of the Codified Ordinances of the City of Massillon, Ohio, by enacting a new Sub-Section 1185.03 (a)(b) and deleting (c) "Basis For Establishing The Areas of Special Flood Hazard" of CHAPTER 1185 "FLOOD PLAIN AREAS" and declaring an emergency.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section I:

The new Sub-Sections 1185.03(a)(b) "Basis For Establishing The Areas of Special Flood Hazard" of the Codified Ordinances of the City of Massillon, Ohio, are hereby enacted.

Section 2:

That there hereby is enacted new Sub-Sections 1185.03(a)(b) "Basis For Establishing The Areas of Special Flood Hazard" of the Codified Ordinances of the City of Massillon, Ohio. The said newly enacted Sub-Sections shall read as follows:

1185.03(a) Flood Insurance Study Stark County, Ohio and Incorporated Areas effective September 29, 2011.

1185.03(b) Flood Insurance Rate Map Stark County, Ohio and Incorporated Areas effective September 29, 2011.

Section 3:

This ordinance is hereby declared to be an emergency measure necessary for the preservation of the health, safety and welfare of the community and for the additional reason that FEMA and the Ohio Department of Natural Resources are requiring the City update the code to reflect changes made to the Code of Federal Regulations. Provided it receives the affirmative vote of two-thirds of the elected members to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
