ORDINANCE NO. 89 - 2011

BY: STREETS, HIGHWAYS, TRAFFIC & SAFETY COMMITTEE

TITLE: AN ORDINANCE authorizing the Director of Public Service and Safety of the City of Massillon, Ohio, to enter into a contract upon approval of the Board of Control with KCI Associates of Ohio for the Construction Administration Services for the 2011 Intersections Improvement Project, and declaring an emergency.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section 1:

The Council of the City of Massillon, Ohio, hereby determines it to be necessary in the public health, safety and welfare to enter into a contract upon approval of the Board of Control with KCI Associates of Ohio for the Construction Administration Services for the 2011 Intersections Improvement Project.

Section 2:

The Director of Public Service and Safety of the City of Massillon, Ohio, is hereby authorized to enter into a contract upon approval of the Board of Control with KCI Associates of Ohio for the Construction Administration Services for the 2011 Intersections Improvement Project. The cost of said project is not to exceed Forty-Nine Thousand Eight Hundred Seventy-Five Dollars (\$49,875.00). The City has received safety funding through ODOT for the project and also a grant from the Stark County Transportation Improvement District making the project 100% funded. Thompson Electric from Monroe Falls is the contractor for the project and anticipates construction beginning the week of July 18, 2011.

Section 3:

This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the health, safety and welfare of the community and for the additional reason that it is necessary that the agreement is signed so the 2011 Intersection Improvement Project may begin in a timely manner. Provided it receives the affirmative vote of two-thirds of the elected members to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
