ORDINANCE NO.73 - 2012

BY: FINANCE COMMITTEE

TITLE: AN ORDINANCE making certain appropriations from the unappropriated balance of the General Fund, 1401 Capital Improvement Fund, Economic Development Fund, Bond Retirement WWT Fund, Tax Increment Fund, WWT Capital Improvement Fund, Menards Inc. Infrastructure Fund, Stormwater Utility Fund and the Inn at University Village Fund, for the year ending December 31, 2012, and declaring an emergency.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section 1:

There be and hereby is appropriated from the unappropriated balance of the General Fund, for the year ending December 31, 2012 the following:

Section 2:

There be and hereby is appropriated from the unappropriated balance of the 1401 Capital Improvement Fund, for the year ending December 31, 2012 the following:

\$424,123.00 to an account entitled "Fire Dept. Equipment" 1401.325.2531

\$266,400.00 to an account entitled "Fire Dept. Tanker" 1401.325.2532

\$ 29,600.00 to an account entitled "Fire Dept. Tanker 2012" 1401.325.2532

Section 3:

There be and hereby is appropriated from the unappropriated balance of the Economic Development Fund, for the year ending December 31, 2012 the following:

\$10,000.00 to an account entitled "Services/Contracts" 1237.845.2392

Section 4:

There be and hereby is appropriated from the unappropriated balance of the Bond Retirement WWT Fund, for the year ending December 31, 2012 the following:

\$6,000.00 to an account entitled "Fees" 1305.940.2393

Section 5:

There be and hereby is appropriated from the unappropriated balance of the Tax Increment Fund, for the year ending December 31, 2012 the following:

\$6,000.00 to an account entitled "Fees" 1340.905.2382

Section 6:

There be and hereby is appropriated from the unappropriated balance of the WWT Capital Improvement Fund, for the year ending December 31, 2012 the following:

There be and hereby is appropriated from the unappropriated balance of the Menards Inc. Infrastructure Fund, for the year ending December 31, 2012 the following:

\$500.00 to an account entitled "County Fees" 1430.905.2393

Section 8:

There be and hereby is appropriated from the unappropriated balance of the Stormwater Utility Fund, for the year ending December 31, 2012 the following:

\$300.00 to an account entitled "County Collection Fees" 2105.549.2393

Section 9:

There be and hereby is appropriated from the unappropriated balance of the Inn at University Village Fund, for the year ending December 31, 2012 the following:

\$250.00 to an account entitled "County Collection Fees" 1429.905.2393

Section 10:

This Ordinance is hereby declared to be an emergency measure, for the efficient operation of the various departments of the City of Massillon and for the preservation of the public health, safety and welfare of the community. Provided it receives the affirmative vote of two-thirds of the elected members to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
