NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section I:

Existing Chapter 163 "RECREATION BOARD" is hereby amended by repealing existing Subsections 163.03 "POWERS AND DUTIES", 163.04 "PARK AND RECREATION DEPARTMENT" and enacting new Subsections 163.03 "POWERS AND DUTIES", 163.04 "PARK AND RECREATION DEPARTMENT" and enacting a new 163.06 "GOLF ADVISIORY COMMITTEE OF THE LEGENDS OF MASSILLON GOLF CLUB" of the Codified Ordinances of the City of Massillon. Said newly enacted Subsections shall read as follows:

Section 2:

The Clerk of Council is authorized to correct any typographical errors discovered herein during or after the pendency or passage of this ordinance. The Clerk of Council is further authorized, in conjunction with the Law Department and the Council President to correct any ministerial or de minimis errors that do not substantially alter the intended results or numerical total sums of this ordinance, during or after the pendency or passage of this ordinance. Corrected copies are to be sent to all official recipients.

Section 3:

This Ordinance shall take effect and be in force from and after the earliest period allowed by law.

163.03 POWERS AND DUTIES.

The Recreation Board shall have the power to equip with nonpermanent personal property and the power to operate playgrounds, play fields, gymnasiums, swimming pools and other recreation centers, including but not limited to, the Massillon Recreation Center, the Senior Citizens Center and the Legends of Massillon Golf Club.

The Recreation Board shall generally act in an advisory capacity, making recommendations to the (Parks and Recreation Director) and to Council concerning the development, maintenance and operation of playgrounds, recreational facilities, and programs for the City, including fees and rates thereof. The Parks and Recreation Board shall also have those powers and perform those duties as Council may provide by ordinance or resolution, including, specifically, the following powers and duties:

- (a) To analyze community needs in the parks and recreation area, and recommend such programs, activities, and improvements as might be deemed necessary to the Parks and Recreation Director and Council.
- (b) To plan for both long-range and short-range expansions and changes in parks, park facilities, and recreation facilities and make such recommendations to the Director and Council.
- (c) To recommend rules and regulations governing the use of parks and recreation facilities such as: closing hours, restrictions on use, and guidelines for use of parks and recreation facilities, subject to the approval by legislation of Council.
- (d) To recommend rates and fees for the municipal golf course and other City parks and recreation facilities, and to recommend rates and fees for other recreational activities, all subject to approval by legislation of Council.
- (e) To monitor the quality of parks and recreational service provided to the public for the purpose of advising the Parks and Recreation Director and Council of existing problems, needs and potential areas of improvement.
 - (f) To assist the Parks and Recreation Director in coordinating City recreational policy with other area organizations, both public and private.

- (g) To receive and review the draft of an annual budget for parks and recreational purposes, and to pass on to Council their recommendations for any additions, deletions, or other changes in the draft the Board feels are necessary or desirable, to be passed on or prior to January 1, to Council for consideration.
- (h) To review and make recommendations to the Parks and Recreation Director and Council concerning the need for capital outlays, or the acquisition of major pieces of equipment in the area of parks and recreation.
- (i) To recommend the purchase, lease, sale, or exchange of real or personal property in the name of the City, which is no longer needed for recreational purposes, within or outside the City, subject to approval of Council.
- (j) The Board shall devise and recommend for adoption by the City a recreational program for children, young people, and men and women in all walks of life; offer leadership in coordinating and correlating all recreational activities to the maximum benefit of the citizens of the City; and cooperate and coordinate the building of the total community recreational program into and around the public and private organizations concerned with public welfare, education, and family relations.

163.04 PARK AND RECREATION DEPARTMENT

The Parks and Recreation Department shall be headed by the Director of Parks and Recreation. No person shall be appointed Director of Park and Recreation unless they have been actively engaged on a full-time basis as a Director or similar level in Parks and Recreation activities for a minimum period of ten (10) years or more prior to his/her appointment. In addition, an individual appointed to the position of Director of Parks and Recreation must have at least a Bachelor's Degree in Parks Administration, Public Administration, Sports Management or similar degree from an accredited institution of higher learning, plus have supervised a minimum of twenty-five (25) employees at one time. A Master's Degree in Park or Recreation Administration or Public Administration is preferred.

The Parks and Recreation Director shall be appointed by the Recreation Board subject to the approval of a majority of the members of Council, with tenure of office during good behavior and efficient service. The Recreation Board may remove the Director for cause and with the consent of five members of Council. However, the Director shall be given the right to be heard at an official meeting of Council before its consent to his or her removal is given. The Recreation Board shall interview and submit a list of candidates to Council, with its recommendations, out of which they may make the appointment

The Director of Parks and Recreation shall have charge of the Park and Recreation Department.

The Director of Parks and Recreation shall have the control and management of parks, park entrances, parkways, children's playgrounds, public recreation facilities, gymnasiums, swimming pools, playfields, or indoor recreational centers, and any lands or buildings set aside for park or recreational use by the public, and the acquisition, construction, repair, and maintenance thereof. The Director shall create and supervise all Recreational Programs for the City of Massillon. The Director shall exercise exclusively all the powers and perform all the duties, in regard to such property, vested in and imposed upon the Director of Public Service by the statutes of the State of Ohio. The Director of Parks and Recreation shall have the responsibility for expenditures of all monies appropriated by the legislative authority of the City in the Parks Fund or received from any other source for the purchase, acquisition, improvement, maintenance, equipment, or enjoyment of all property under his/her control, but no liability shall be incurred or expenditure made unless the money required therefore is in the Treasury to the credit of the Park and Recreation Fund and not appropriated for any other purpose.

The Director of Parks and Recreation may employ recreational supervisors, engineers, clerks, and other necessary employees for carrying Into effect the purposes of the Department's creation, and the Council shall fix the compensation and term of service of such employees within its appropriation.

The Director of Parks and Recreation, in letting of contracts, shall be governed by the bidding procedures of the City of Massillon.

ADMINISTRATION <u>Budget</u>. The annual budget for parks and recreational purposes and all parks and recreation policy as approved by Council shall be administered by the **Parks** and **Recreation** Director.

163.06 GOLF ADVISORY COMMITTEE OF THE LEGENDS OF MASSILLON GOLF CLUB.

There is hereby established a Golf Advisory Committee of the Legends of Massillon Golf Club which shall be composed of five members, who are not required to be members of the Golf Club, but who shall be residents of the City and appointed to threeyear terms, such terms to be staggered originally for periods of one, two and three years. The Committee shall be appointed by the Parks and Recreation Director. A member of the Recreation Board, the Legends of Massillon Golf Superintendent, or his/her designee and the Chair Person of the Massillon City Council Parks and Recreation Committee shall serve on the Committee but act without vote. Such Committee shall have no official status with the City, and Committee members shall not be entitled to any compensation from the City. The duties of the Committee shall be to regularly meet with the Legends of Massillon Golf Club members and golfing public to have an understanding of the concerns and recommendations of the members and the public regarding the operation and maintenance of the Legends of Massillon Golf Club. The Committee shall incorporate those concerns and recommendations into regular communications with the Legends of Massillon Golf Superintendent, the Parks and Recreation Director and the Parks and Recreation Board, with such communications to include the expertise of the Committee as it provides such recommendations.

LIMITATIONS/PROVISIONS ON THE USE OF A SPECIAL HAULING PERMIT

THIS IS A TWO-SIDED FORM AND MUST BE CARRIED IN ITS ENTIRETY

GENERAL PROVISIONS & LIMITATIONS

- The granting of this permit does not guarantee that the load described can be moved without damage to the pavement or structures although the permit is
 granted on the assumption that the load can be moved without damage, based on the best information available.
- 2) Permittee will be held liable for any damage caused by the movement. The City of Massillon assumes no responsibility for damage to the permittee's equipment or load being moved due to any such failure. The permittee agrees to compensate the City of Massillon for any damage to a roadway or road structure and also to hold The City of Massillon harmless from all claims, damages, or proceedings of any kind and from all responsibility for personal injury or property damages (public or private) caused directly or indirectly as a result of the transportation of said vehicle(s) or object(s).
- 3) If requested, the applicant must file a bond or certificate of his liability insurance, showing that he has procured adequate bond or insurance to cover the provisions of the previous paragraph 2.
- 4) The Special Hauling Permit (SHP) shall be in the possession of the drive at all times during the progress of transportation and will be shown on demand to any Deputy Sheriff, State Highway Patrolman, or other law enforcement officer.
- 5) The permission granted restricts the movement of the vehicle(s) or object(s) to only the City of Massillon roads specified, between the points designated, and within the time allotted. Permittee is responsible to check the route for abnormal, changed, or unknown conditions, which may exist during any move.

 Permission to travel state routes, township roads or local streets not part of the City of Massillon's road system must be obtained from the proper authorities.
- 6) No vehicle(s) or object(s) being transported under a Special Hauling Permit shall be left parked on the roadway either day or night except in case of an emergency, in which case adequate protection shall be provided for the traveling public. The vehicle(s) shall not be loaded or unloaded within the limits of the highway.
- 7) The operator of the vehicle must comply with all laws, rules, or regulations covering the movement of traffic over highways and streets.
- Special Hauling Permits will not generally be issued for a built-up load that is divisible into legal loads or loads that have not been loaded to the least over dimension or the least overweight. Miscellaneous items may, however, be transported on the same vehicle with an over dimension piece or pieces so long as the miscellaneous items do not add to the over dimension. It is not necessary to identify these miscellaneous items. If, in the event of an extenuating circumstance, a permit is issued for a divisible load in which two or more pieces add to the over dimension or overweight, such load will be adequately described.
- 9) A Special Hauling Permit is void at any time road, weather, or traffic conditions make travel unsafe, as determined by the City of Massilton.
- 10) Movement of mobile homes, manufactured structures, office trailers, and park model recreational vehicles is prohibited when wind velocity exceeds 20 mph.

OPERATING LIMITATIONS

- 1) No vehicle(s) or object(s) being transported under a Special Hauling Permit shall travel in convoy with any other oversize/overweight vehicle or vehicle and load. Every vehicle operating under a SHP shall maintain a minimum spacing of 500' from all vehicles traveling in front and in the same lane as said vehicle whenever possible. No vehicle operating under a Special Hauling Permit shall pass other vehicles traveling in the same direction.
- Any load with an overall height in excess of 14 feet 10 inches shall be required to coordinate the move with the owners of all overhead signs, signals, utilities, etc., which may obstruct safe, clear movement.
- Reductions in legal weight posted on roadways or bridges must be obeyed. Contact the City of Massillon's Engineer's Office immediately if your route includes legal load reductions.
- 4) Movement of all vehicles/loans traveling under an Annual Oversized of Legal Weight Special Hauling Permit that exceed the posted weight of the 25% seasonal weight reduction on City of Massillon's roads shall acquire an additional permit for each movement on said roads while the reductions are in effect.

DAYS/HOURS OF OPERATION

- Overweight vehicle/loads that are not over dimensional, traveling under the authority of a Special Hauling Permit, will not be restricted as to travel hours or days so long as the overweight vehicle/load can move without obstructing the normal flow of the traffic.
- With the exception of permitted legal dimensioned overweight vehicle/loads noted in 1) above, vehicle/loads traveling under the authority of Special Hauling Permits shall be prohibited from movement on the holidays listed by ODOT's Oversize/Overweight Special Hauling Permits Holiday Restrictions Notice. Holiday prohibitions begin at noon the day preceding and continue until one-half hour before sunrise the day following the holiday or holiday weekend.
- 3) Movement of all vehicles/loads in excess of twelve feet in width shall be prohibited during the following travel times:

 Saturday from 3:00 P.M. until ½ hour before sunrise on the following Sunday

 Sunday from 3:00 P.M. until ½ hour before sunrise on the following Monday

 Friday from 3:00 P.M. until ½ hour before sunrise on the following Saturday (April 1 through November 30)

 These time limitations are in addition to item 2) of the Days/Hours of Operation, above.
- 4) With the exception of limits noted in 1), 2) and 3) above, permit vehicles and loads may move during daylight hours, Sunday through Saturday. Daylight hours are defined as one-balf hour before sunrise until one-half hour after sunset.

WARNING FLAGS AND SIGNS

- 1) Warning flags shall be displayed on all over dimensional vehicles and loads. Warning flags shall be 18 inches square, red or orange in color, in good repair and free of printing or other markings and shall be securely fastened by at least one corner or securely mounted on a staff.
- Over width vehicles and loads shall bear two flags at the widest extremities of the vehicle or load as well as one flag at each corner of the vehicle or load.
 Warning flags are not required to be displayed on the tractor.
- 3) Over length vehicles and loads or vehicles and loads with a rear overhang of 4 feet or greater shall display a single flag at the extreme rear if the over length or projecting part is two feet wide or less. Two flags shall be displayed if the over length or projecting portion is wider than two feet and the flags should be located to indicate maximum width.
- 4) Warning signs, when required, shall be in good repair, shall read "OVERSIZE LOAD" and shall be at least 7 feet long and 18 inches high. The sign's background shall be yellow with black lettering. Letters shall be at least 10 inches with a 1.41 inch brush stroke. If series E Modified is used, the brush stroke is to be two inches.
- OVERSIZE LOAD signs shall be displayed on any vehicle or vehicle/load exceeding the maximum legal length limit as set forth in the Ohio Revised Code, Section 5577.05.
- 6) OVERSIZE LOAD signs shall be displayed on any vehicle or vehicle/load with an overall width of 10 feet or greater.
- 7) OVERSIZE LOAD signs shall be displayed on any vehicle or vehicle/load with an overall height in excess of 14 feet 6 inches.
- 8) OVERSIZE LOAD signs, when required, shall be displayed on the front and rear of the over dimensioned vehicle or vehicle/load.

LIGHTING

 All Permitted vehicles' standard vehicle lighting must be in operating order. THE HEADLIGHTS MUST BE ON DURING THE MOVEMENT OF ANY OVER DIMENSION VEHICLE/LOAD.

ESCORT VEHICLES

- 1) Escort vehicles, when required by a Special Hauling Permit to accompany an over dimensional or overweight vehicle/load, shall be required to display a warning sign, yellow with black letters, reading "OVERSIZE LOAD". The sign shall be 5 feet long by 12 inches high with 8 inch high letters and shall be in good repair. Escort vehicles shall also be required to maintain radio communication with the operator of the permitted vehicle and shall also be required to be equipped with a roof mounted amber flashing or rotating light(s). Driver of the escort vehicle is to act as a flagger when needed.
- 2) One rear escort vehicle shall be required for the transportation of any vehicle/load with an overall length in excess of 90 feet.
- 3) One lead escort vehicle shall be required for the transportation of any vehicle/load with an overall width in excess of 12 feet.
- 4) One lead escort vehicle equipped with a height-sensing device shall be required for the transportation of any vehicle/load with an overall height in excess of 14 feet 6 inches.
- 5) One lead and one rear escort shall be required on any vehicle or vehicle/load with an overall width in excess of 14 feet 6 inches.
- 6) One lead and one rear escort shall be required on any vehicle or vehicle/load with an overall height in excess of 14 feet 10 inches.
- 7) If more than one of the conditions set forth in numbers 2) through 4) above are met, (for example, a load exceeding 12 feet in width and 90 feet in length), two escorts (one lead and one rear) shall be required.
- Lead escort vehicle, when required, is to proceed 500 feet in advance of permit vehicle/load.
- Rear escort vehicle, when required, is to follow 500 feet in back of permit vehicle/load.

FLAGGERS

Flaggers shall be used when limited sight distance or hazards are encountered.

PENALTY FOR VIOLATION

- Failure to comply with the general or special provisions of a Special Hauling Permit, exceeding the weights or dimensions granted, or operating on dates or
 upon highways other than assigned shall render the permit null and void and the operator of the vehicle subject to arrest, as provided in Sections 5577.02 to
 5577.05 inclusive, of the Ohio Revised Code.
- 2) These limitations and provisions describe the general requirements placed on the operation of over dimension and overweight vehicles traveling on Massillon City roads, and are in addition to specific provisions stated on the permit or its attachments. Section 2:
