NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section 1:

It is hereby determined to be in the best interest and promotion of the general health, safety and convenience, comfort, prosperity and welfare of the community to change the designation of the area set forth in Section 2 hereof from R-1 Single Family Residential to RM-1 Multiple Family Residential. Said rezoning was approved by the Planning Commission of the City of Massillon, Ohio, on August 14th, 2013 and that notice and public hearing has been given according to law.

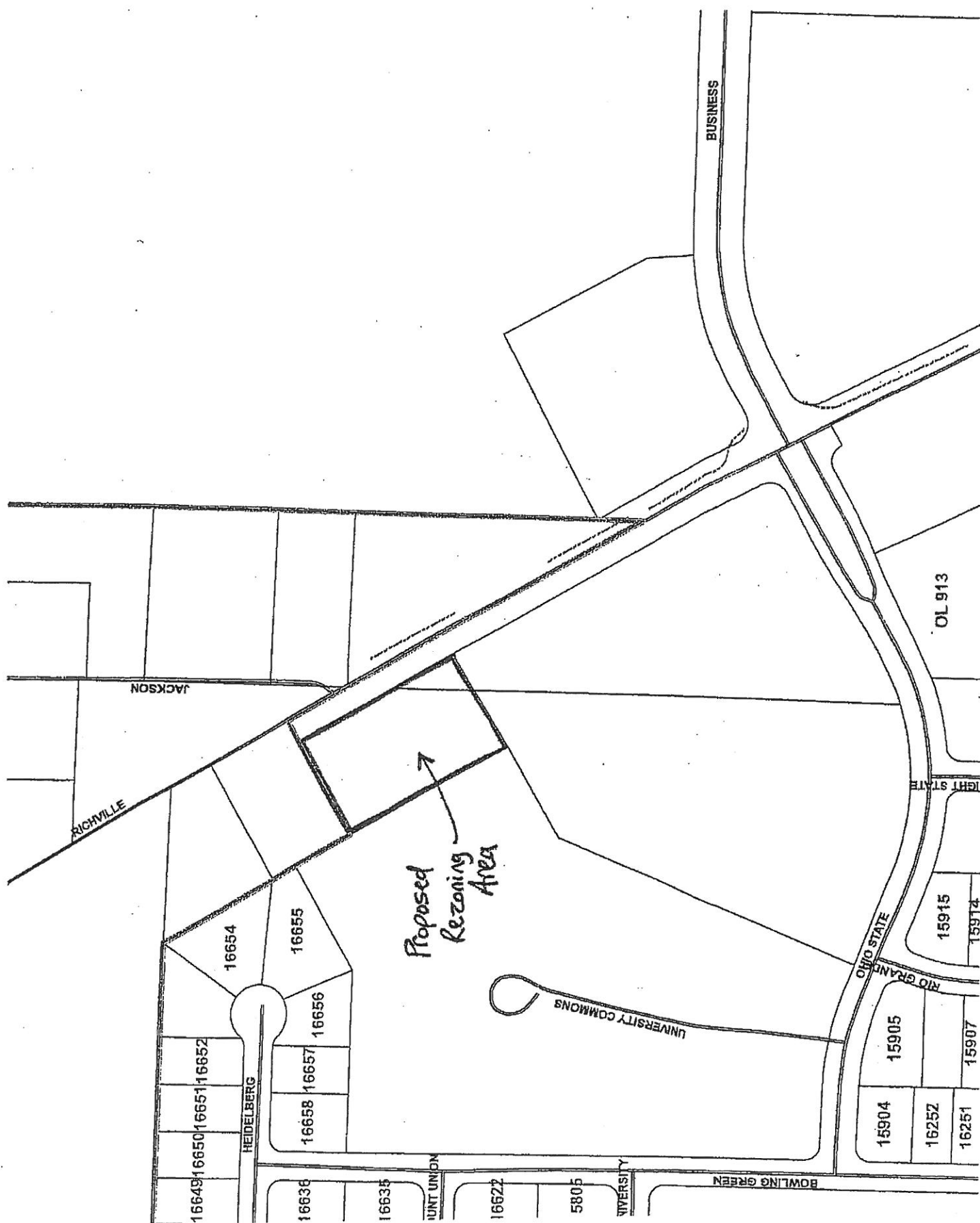
Section 2:

Being known as Out Lot 901, a 1.26 acre area located just north of the Inn at University Village. The applicant is Tobin Enterprise, LLC as agent for Roger Perkins, property owner. The applicant proposes to construct two, three unit townhouse apartment buildings.

Areas of responsibility include general administration, recreations services, parks/facilities maintenance, and golf operations/maintenance.

DUTIES

Assist with assessing leisure and recreational needs of the community by maintaining continuing contact via meetings, public presentations, and correspondence with community leaders, civic groups and public officials, and devises and implements plans and programs to address identified needs.

Works with the Director with regards to overseeing all department operations, including revenue and expenditure activities, evaluation of programs and employees, supervision of facilities, and coordination of all other departmental activities.

Coordinates departmental operations and programs with other local, state, and federal agencies and officials.

Represents department before various Boards and Commissions as needed, including the Recreation Board, City Council, and School Board.

Recommends policy and major program initiatives to Director of Parks and Recreation and the Recreation Board.
