ORDINANCE NO. 59 – 2015

TITLE: AN ORDINANCE approving the proposed rate adjustments for special events at The Legends of Massillon Golf Course for the year 2015, and declaring an emergency.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section 1:

The Council of the City of Massillon, Ohio, hereby determines that it is necessary to approve the proposed rate adjustments for The Legends of Massillon Golf Course for the year 2014.

Section 2:

It is hereby determined that the following various fees and charges for The Legends of Massillon Golf Course for the year 2015 are hereby approved and accepted by this Council.

Section 3:

This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the health, safety and welfare of the community and for the further reason that the proposed rate adjustments are necessary for the efficient operation of The Legends of Massillon Golf Course. Provided it receives the affirmative vote of two-thirds of the elected members to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
