Section 1:

It is hereby determined to be in the best interest and promotion of the general health, safety and convenience, comfort, prosperity and welfare of the community to change the designation of the area set for in Section 2 hereof from I-1 Light Industrial to RM-1 Multiple Family Residential for the north portion and from I-1 Light Industrial to A-1 Agriculture for the south portion. Said rezoning was approved by the Planning Commission of the City of Massillon, Ohio, on May 27, 2015 and that notice and public hearing has been given according to law.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section 1:

Subject to the approval of the electors of the City of Massillon as provided in Section 718.01 of the Revised Code of Ohio, new Section 181.031 LEVY OF ADDITIONAL TAX is hereby enacted and shall read as follows:

181.031 LEVY OF ADDITIONAL TAX

In addition to the income tax levied pursuant to Section 181.03, there is hereby levied, to provide funds for the purpose of expenses of operation of the municipal government, a tax upon earnings at the additional rate of two-tenths (.2) of one percent (1.0%) upon those items enumerated in Section 181.03. One-tenth of one percent (1.0%) shall be specifically dedicated for the purpose of funding the City Vehicle Replacement Plan for Streets and Highway Division and provide funding for City Street Repair/Repaving. One-tenth of one percent (1.0%) shall be payable to the General Fund.

Section 2:

That this Ordinance amending certain sections in CHAPTER 181 of the Codified Ordinances of the City of Massillon shall only be effective upon the approval by the electors of the City of Massillon at the Primary Election to be held in the spring of 2016, in regard to the aforesaid increase of the income tax rate. Provided, however, that if the approval is not received, this ordinance, which amends certain sections of CHAPTER 181 of the Codified Ordinances of the City of Massillon, shall be of no effect and the aforesaid sections shall be in full force and effect as presently written in CHAPTER 181.

Section 3:

That this is the desire and request of the Council of the City of Massillon, that the ballot for said question shall be substantially in the following form:

One-tenth of one percent (1.0%) shall be payable to the General Fund.

TITLE: AN ORDINANCE amending Section 181.15 "CREDIT FOR TAX PAID TO ANOTHER MUNICIPALITY" OF CHAPTER181 "INCOME TAX" of the Codified Ordinances of the City of Massillon by enacting a new Section 181.15 "CREDIT FOR TAX PAID TO ANOTHER MUNICIPALITY" of said CHAPTER 181 "INCOME TAX".

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section I:

Section 181.15 "CREDIT FOR TAX PAID TO ANOTHER MUNICIPALITY" of said CHAPTER 181 "INCOME TAX" of the Codified Ordinance of the City of Massillon be and hereby is repealed.

Section 2:

That there be and hereby is enacted a new Section 181.15 "CREDIT FOR TAX PAID TO ANOTHER MUINICIPALITY" of said CHAPTER 181 "INCOME TAX" of the Codified Ordinance of the City of Massillon. Said section shall read as follows:

181.15 CREDIT FOR TAX PAID TO ANOTHER MUNICIPALITY

- (a) Where a resident of this Municipality is subject to a municipal income tax in another municipality or in a joint economical development district, such resident shall be allowed a credit of the amount of income tax paid on such taxable income to such other municipality on the first 1.8% of such income earned.
- (b) Every individual taxpayer who resides in this municipality who receives net profits, Salaries, wages, commissions, or other personal service compensation for work done or services performed or rendered outside of this municipality, if it is made to appear that he had paid a municipal income tax on the same income taxable under this chapter to another municipality or in a joint economical district, shall be allowed

a credit in the amount of 1.8% against the tax imposed by this chapter in the amount paid by him or in his behalf to the other municipality or a joint economical development district. The credit shall not exceed the amount of 1.8% of tax assessed by this chapter on the income earned in the other municipality or municipalities or in a joint development district, where the tax is paid.
