The Council of the City of Massillon, Ohio, hereby determines it necessary in the public health, safety and welfare for the Director of Public Service and Safety of the City of Massillon, Ohio, to enter into a lease agreement with the Ford Credit Municipal Finance Program. The lease agreement will allow the Massillon Police Department to acquire a 2016 Ford Transit Van 350 for the purpose of transporting prisoners between the Stark County Jail and the Massillon Municipal Court.
