ORDINANCE NO. 166 - 2017

BY: PARKS AND RECREATION COMMITTEE

TITLE: AN ORDINANCE amending Chapter 163 "PARK AND RECREATION BOARD" of the Codified Ordinances of the City of Massillon, Ohio, by repealing existing Subsections 163.03 "POWERS AND DUTIES" and 163.04 "PARK AND RECREATION DEPARTMENT," and enacting new Subsections 163.03 "POWERS AND DUTIES" and 163.04 "PARK AND RECREATION DEPARTMENT," of the Codified Ordinances of the City of Massillon, and declaring an emergency.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section 1:

Ordinance No. 73 – 2013 be and is hereby repealed.

Section 2:

That there be and hereby is enacted a new Section 163.03 "POWERS AND DUTIES" of Chapter 163, which shall read as follows:

"The Recreation Board shall possess all the powers and be subject to all the responsibilities of the local authorities under Ohio R.C. 755.12 to 755.18."

Section 3:

That there be and hereby is enacted a new Section 163.04 "PARK AND RECREATION DEPARTMENT" of Chapter 163, which shall read as follows:

"A City of Massillon Park and Recreation Department is hereby created within the City. The Park and Recreation Board shall determine the positions needed for the operation of the Department. The necessary staffing, wages and the budget to operate the Department shall be submitted by the Recreation Board to the Mayor and then forwarded to Council for approval."

Section 4:

The Clerk of Council is authorized to correct any typographical errors discovered herein during or after the pendency or passage of this ordinance. The Clerk of Council is further authorized, in conjunction with the Law Department and the Council President to correct any ministerial or de minimis errors that do not substantially alter the intended results or numerical total sums of this ordinance, during or after the pendency or passage of this ordinance. Corrected copies are to be sent to all official recipients.

Section 5:

That this Ordinance is declared to be an emergency measure for the efficient operation of the various departments of the City of Massillon and for the preservation of the health, safety and welfare of the community. Provided it receives the affirmative vote of two-thirds of the elected members to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

ORDINANCE NO. 167 - 2017

BY: PARKS AND RECREATION COMMITTEE

TITLE: AN ORDINANCE amending Chapter 163 "PARK AND RECREATION BOARD" of the Codified Ordinances of the City of Massillon, Ohio, by repealing existing Subsection 163.02 "MEMBERS," and enacting new subsection 163.02 "MEMBERS," of the Codified Ordinances of the City of Massillon, and declaring an emergency.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section 1:

That existing Subsection 163.02 is hereby repealed. That there be and hereby is enacted a new Section 163.02 "MEMBERS" of Chapter 163, which shall read as follows:

"The Park and Recreation Board shall consist of five members, two of whom shall be members of the Board of Education of the City or shall be appointed by the Board of Education. The other three members of the Recreation Board shall be appointed by the Mayor with the consent of Council. The members who are Board of Education members and members appointed by the Board of Education shall be residents of the school district making the appointment but need not be residents of the City. All other members of the Board shall be residents of the City. All members of the Board shall serve for terms of five years, except that the members first appointed shall be appointed for such terms that the term of one member shall expire annually thereafter. Members of the Board shall serve without pay. Vacancies in the Board, occurring otherwise than by expiration of term, shall be for the unexpired term and shall be filled in the same manner as original appointments."

Section 2:

The Clerk of Council is authorized to correct any typographical errors discovered herein during or after the pendency or passage of this ordinance. The Clerk of Council is further authorized, in conjunction with the Law Department and the Council President to correct any ministerial or de minimis errors that do not substantially alter the intended results or numerical total sums of this ordinance, during or after the pendency or passage of this ordinance. Corrected copies are to be sent to all official recipients.

Section 3:

That this Ordinance is declared to be an emergency measure for the efficient operation of the various departments of the City of Massillon and for the preservation of the health, safety and welfare of the community. Provided it receives the affirmative vote of two-thirds of the elected members to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
