WHEREAS, Council resolves to specify the date of said election as the general election on November 7, 2017.

# Massillon Museum Board of Directors Resolution

Request of Massillon City Council to place a 1.5 Mill levy, which would encompass the 1 Mill renewal of the current tax levy, and a .5 Mill additional increase to the levy, on the 2017 general election ballot for the continued operation of the Massillon Museum.

Whereas, The Massillon Museum collects, preserves and exhibits art and artifacts, to enrich our community through education and experience; and

Whereas, The Massillon Museum has been an integral part of Massillon's heritage, and has served as a repository of Massillon's history, art and culture since 1933, with a collection encompassing approximately 100,000 objects in 94 distinct categories; and

Whereas, The Massillon Museum has operated under the same 1 Mill tax levy since it was initially approved in 1988, and has not asked for an increase in millage for almost twenty years despite inflationary pressures, and costs rising over time; and

Whereas, An additional .5 Mill increase to the levy is essential to maintain the Massillon Museum's facilities, to preserve the community's heritage, and to continue to provide programming that best serves the citizens of Massillon.

Now, Therefore Be It Resolved that the Board of Directors of the Massillon Museum hereby requests the Massillon City Council to take all steps necessary to place a 1.5 Mill levy, which would encompass the 1 Mill renewal of the current tax levy, and a .5 Mill additional increase to the levy, on the 2017 general election ballot to be held on November 7, 2017, for the continued operation of the Massillon Museum.

Member Mattew Onest moved the adoption of the preceding Resolution, which was seconded by member Elizabeth Witt. A vote was taken and the result was:
