RESOLUTION NO. 1 - 2019

TITLE: A RESOLUTION authorizing the sale, by Internet Auction during calendar year 2019, of City owned personal property which is not needed for public use or which is obsolete or unfit for the use for which it was acquired.

WHEREAS, pursuant to R.C. 721.15(D), Council for the City of Massillon, may adopt, during each calendar year, a resolution expressing its intent to sell municipally owned property, regardless of the property's value, by internet auction; and

WHEREAS, Council for the City of Massillon has determined that it is advantageous to contract with an Government Internet Auction Site, such as www.govdeals.com, or another provider in the business of auctioning unneeded government property as the City's representative to conduct auctions on its behalf for city owned property which is not needed for public use or which is obsolete or unfit for the use for which it was acquired.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Massillon, County of Stark, State of Ohio, as follows:

Section 1.

During calendar year 2019, city owned personal property which is not needed for public use, or which is obsolete or unfit for the use for which it was acquired, may be sold at internet auction.

Section 2.

All internet auction sales shall be conducted under the authority and direction of the Safety Service Director or his designee.

Section 3.

All internet auction sales of municipal personal property, shall be conducted by GovDeals.com internet auction service or another provider in the business of conducting auctions for unneeded, obsolete or unfit government property.

Section 4.

All internet auction sales shall be conducted pursuant to the rules and regulations promulgated and then in effect for the chosen provider. The City of Massillon will maintain a link to the current internet auction service on its website, www.massillonohio.com to inform the public of the providers name, address, telephone number and rules and regulations for current auctions.

Section 5.

For each internet auction sale, bidding shall remain open for not less than ten (10) days, including Saturdays, Sundays and legal holidays.

Section 6.

That it is FOUND and DETERMINED that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including those of Section 121.22 of the Ohio Revised Code.
