RESOLUTION NO. 4 - 2019

TITLE: A RESOLUTION supporting the 80th Anniversary of Stark Metropolitan Housing Authority for the services they provide to the citizens of Stark County which includes the citizens of Massillon, Ohio.

WHEREAS, The Housing Act was established in 1937 to provide subsidies to improve the living conditions for low-income families. In 1939, the Ohio State Board of Housing establishes the Canton Metropolitan Housing Authority as the 18th public housing authority in the State of Ohio and in 1970, the name was changed to Stark Metropolitan Housing Authority; and

WHEREAS, the Mission Statement of Stark Metropolitan Housing Authority is "To provide eligible residents of Stark County with decent, safe and affordable housing and contribute to nourishing neighborhoods by working in partnership with the public and private sectors"; and

WHEREAS, Stark Metropolitan Housing Authority has, through a contract with the U.S. Department of Housing and Urban Development, operated a Section 8 Program in Stark County for over 30 years, providing housing assistance to approximately 1,500 families; and

WHEREAS, the City of Massillon, Ohio, is the home of over 300 housing units and the Lillian P. Beane Center, and Stark Metropolitan Housing Authority administers programs that serve the needs of homeless individuals and families in our community with transitional and permanent supportive housing.

Now, therefore be it resolved that the City of Massillon, Stark County, Ohio, is fully supportive of the 80th Anniversary of Stark Metropolitan Housing Authority to assure the continuation of its services to the citizens of Stark County, including the citizens of Massillon, Ohio.
