TITLE: AN ORDINANCE amending SECTION 181.01 “PURPOSE AND AUTHORITY TO LEVY TAX; RATE” of the Codified Ordinances of the City of Massillon, Ohio, and authorizing the continuation of an existing two-tenths of one percent (0.2%) levy on income, to be effective January 1, 2022, for five (5) years, for the purpose of City Street Maintenance and Repair and the City Street Department, subject to the approval of the electors of the City of Massillon, Ohio, at an election to be conducted at the Primary Election on May 4, 2021.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section 1:

Subject to the approval of the electors of the City of Massillon, Ohio, as provided in Section 718.04 of the Ohio Revised Code, Council authorizes the continuation of an existing two-tenths of one percent (0.2%) levy on income and, accordingly, directs that SECTION 181.01 “PURPOSE AND AUTHORITY TO LEVY TAX; RATE” of the Codified Ordinances of the City of Massillon, Ohio, is hereby amended and shall read as follows:

**181.01 PURPOSE AND AUTHORITY TO LEVY TAX; RATE.**

**181.011 AUTHORITY TO LEVY TAX.**

(A) The tax on income and the withholding tax established by this Chapter 181 are authorized by Article XVIII, Section 3 of the Ohio Constitution. The tax on income and the withholding tax established by this Chapter 181 are deemed to be levied in accordance with, and to be consistent with, the provisions and limitations of Ohio Revised Code 718 (ORC 718). This Chapter is deemed to incorporate the provisions of ORC 718.

(B) The tax is an annual tax levied on the income of every person residing in or earning or receiving income in the municipal corporation, and shall be measured by municipal taxable income. The Municipality shall tax income at a uniform rate. The tax is levied on Municipal Taxable Income, as defined herein.

### **181.012 PURPOSES OF INCOME TAX; RATE.**

(A) The tax on income and the withholding tax established by this Chapter 181 are to provide funds for general municipal operations, capital improvements, and for other municipal purposes of the City of Massillon, Ohio.

(B) The tax on income and the withholding tax shall be levied on and after January 1, 2016, at the rate of one and eight-tenths percent (1.8%) per annum for the purposes specified in division (A) of this section, with three-tenths of one percent (0.3%) to be specifically dedicated for Parks and Recreation funding and purposes.

### **181.013 LEVY OF ADDITIONAL TAX.**

Effective January 1, 2022, for five (5) years, the tax on income and the withholding tax referenced above in Section 181.012 shall be levied at the rate of two percent (2%) per annum, with the additional two-tenths of one percent (0.2%) provided for in this Section to be specifically dedicated for the purpose of City Street Maintenance and Repair and the City Street Department.

### **181.014 ALLOCATION OF FUNDS.**

(A) The funds collected under the provisions of this chapter shall be disbursed as follows:

(1) All funds collected that are to be specifically dedicated, as provided in Sections 181.012 and 181.103 above, shall be allocated accordingly.

(2) In regard to all other funds collected, ninety-four percent (94%) shall be deposited in the "1100 General Fund" and six percent (6%) shall be deposited in the "1401 Income Tax Capital Improvements Fund" and shall be used for capital improvements to defray operating expenses of the City including such part thereof as shall be necessary to defray all costs of administering and enforcing the provisions thereof.

(3) Capital Improvements are all property, assets, machinery, equipment, or improvements which the City is authorized by law to acquire, construct and maintain, including plans and studies thereof with an estimated life or usefulness of five (5) years or more, including land and interests therein, and including reconstructions, enlargements and extension thereof having an estimated life or usefulness of five (5) years or more provided, however, that the purchase of motorized equipment for the various City departments and the resurfacing and resealing of public streets, including "Chip and Seal" method, shall be deemed Capital Improvement without regard to estimated life or usefulness.



**181.015 STATEMENT OF PROCEDURAL HISTORY; STATE MANDATED CHANGES TO MUNICIPAL INCOME TAX.**

(A) Significant and wide-ranging amendments to ORC 718 were enacted by Am Sub HB 5, passed by the 130th General Assembly, and signed by the Governor on December 19, 2014, and H.B. 5 required municipal corporations to conform to and adopt the provisions of ORC 718 in order to have the authority to impose, enforce, administer and collect a municipal income tax.

(B) As mandated by H.B. 5, municipal income tax Ordinance No. 159-2015, effective January 1, 2016, comprehensively amends Title Nine, Chapter 181 of the Municipality's Codified Ordinances in accordance with the provisions of ORC 718 to allow the Municipality to continue the income tax and withholding tax administration and collection efforts on behalf of the Municipality.

Section 2:

The Clerk of Council is authorized to correct any typographical errors discovered herein during or after the pendency or passage of this Ordinance. The Clerk of Council is further authorized, in conjunction with the Law Department and the Council President, to correct any ministerial or de minimis errors that do not substantially alter the intended results or numerical total sums of this Ordinance, during or after the pendency or passage of this Ordinance. Corrected copies are to be sent to all official recipients.

Section 3:

This Ordinance shall only be effective upon the approval of the electors of the City of Massillon, Ohio, at an election to be conducted at the Primary Election on May 4, 2021. If said approval is not received, this Ordinance, which amends Section 181.01 of the Codified Ordinances of the City of Massillon, Ohio, shall be of no effect, and Section 181.01, as it is presently written, shall continue to be in full force and effect without amendment. If said approval is received, then, for municipal taxable years beginning before January 1, 2022, the City of Massillon, Ohio, shall continue to administer, audit, and enforce the income tax of the City of Massillon, Ohio, in accordance with Section 181.01 of the Codified Ordinances of the City of Massillon, Ohio, as said section was written prior to this Ordinance taking effect.

This Ordinance shall take effect from and after the earliest period allowed by law.

**TITLE:** A RESOLUTION directing the Stark County Board of Elections to conduct an election at the Primary Election on May 4, 2021, for the purpose of providing the electors of the City of Massillon, Ohio, with the opportunity to approve or disapprove an ordinance providing for the continuation of an existing two-tenths of one percent (0.2%) levy on income, to be effective January 1, 2022, for five (5) years, for the purpose of City Street Maintenance and Repair and the City Street Department, and declaring an emergency.

WHEREAS, on May 2, 2016, the Council of the City of Massillon, Ohio, passed Ordinance No. 66 – 2016, which provided for a two-tenths of one percent (0.2%) levy on income, increasing the municipal income tax rate from one and eight-tenths percent (1.8%) to two percent (2%), to be effective January 1, 2017, for five (5) years, for the purpose of City Street Maintenance and Repair and the City Street Department; and

WHEREAS, the two-tenths of one percent (0.2%) levy on income provided for in Ordinance No. 66 – 2016 was subject to the approval of the electors of the City of Massillon, Ohio, at an election conducted at the Special Election on August 2, 2016; and

WHEREAS, a majority of the electors of the City of Massillon, Ohio, voting on the question at said election approved the two-tenths of one percent (0.2%) levy on income provided for in Ordinance No. 66 – 2016; and

WHEREAS, upon due investigation and consideration, the Council of the City of Massillon, Ohio, has determined that the continuation of the existing two-tenths of one percent (0.2%) levy on income is necessary to continue to provide an adequate amount of funds for the purpose of City Street Maintenance and Repair and the City Street Department; and

WHEREAS, said Council has determined that it is in the best interest of the public peace, health, or safety of the citizens of the City of Massillon, Ohio, for Council to direct the Stark County Board of Elections to conduct an election at the Primary Election on May 4, 2021, for the purpose of providing the electors of the City of Massillon, Ohio, an opportunity to approve or disapprove an ordinance providing for the continuation of the existing two-tenths

of one percent (0.2%) levy on income, to be effective January 1, 2022, for five (5) years, for the purpose of City Street Maintenance and Repair and the City Street Department; and

WHEREAS, Council has passed Ordinance No. 151 – 2020, which provides for the continuation of the existing two-tenths of one percent (0.2%) levy on income; and

WHEREAS, in accordance with Ohio Revised Code Section 718.04(C)(2), no municipal corporation shall levy a tax on income at a rate in excess of one percent (1%) without having obtained the approval of the excess by a majority of the electors of the municipality voting on the question at a general, primary, or special election; and

WHEREAS, Council resolves to specify the date of said election as the Primary Election on May 4, 2021.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MASSILLON, OHIO, THAT:

Section 1:

There shall be submitted to the electors of the City of Massillon, Ohio, the question of approving or disapproving Ordinance No. 151 – 2020, which provides for the continuation of an existing two-tenths of one percent (0.2%) levy on income, to be effective January 1, 2022, for five (5) years.

Section 2:

The tax is an annual tax for the period specified above, levied on the income of every person residing in or earning or receiving income in the City of Massillon, Ohio, and the tax shall be measured by municipal taxable income.

Section 3:

The City of Massillon, Ohio, is levying the tax in accordance with the limitations of Chapter 718 of the Ohio Revised Code and this Resolution hereby incorporates the provisions of said Chapter 718.

Section 4:

A credit, as described in division (D) of Section 718.04 of the Ohio Revised Code, will be allowed against the tax, to the extent provided for in Chapter 181 of the Codified Ordinances of the City of Massillon, Ohio.

Section 5:

The tax is levied for the purpose of City Street Maintenance and Repair and the City Street Department.

Section 6:

The Stark County Board of Elections is hereby directed to conduct an election to be held at the Primary Election on May 4, 2021, for the purpose of providing the electors of the City of Massillon, Ohio, with the opportunity to approve or disapprove Ordinance No. 151 – 2020, which provides for the continuation of an existing two-tenths of one percent (0.2%) levy on income.

Section 7:

It is the desire and request of Council that the ballot language presented to the electors of the City of Massillon, Ohio, at said election be substantially in the following form:

PROPOSED MUNICIPAL INCOME TAX  
CITY OF MASSILLON

A majority affirmative vote is necessary for passage.

Shall the Ordinance providing for the continuation of an existing two-tenths of one percent (0.2%) levy on income, to be effective January 1, 2022, for five (5) years, for the purpose of City Street Maintenance and Repair and the City Street Department be passed?

AGAINST THE INCOME TAX"

Section 8:

The submission of the proposed continuation of an existing two-tenths of one percent (0.2%) levy on income, the notice of election, the form of ballot, the certification of the continued tax as voted outside the one percent (1%) limitation, and the levying of such tax shall be in accordance with the provisions of Ohio Revised Code Section 718.04(C)(2) and other related Sections of the Ohio Revised Code, in accordance with the statutes in such cases made and provided.

Section 9:

The Clerk of Council is directed to cause notice of the aforementioned election to be published as required by law.

Section 10:

The Clerk of Council is authorized to correct any typographical errors discovered herein during or after the pendency or passage of this Resolution. The Clerk of Council is further authorized, in conjunction with the Law Department and the Council President, to correct any ministerial or de minimis errors that do not substantially alter the intended results or numerical total sums of this Resolution, during or after the pendency or passage of this Resolution. Corrected copies are to be sent to all official recipients.

Section 11:

This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, or safety of the citizens of the City of Massillon, Ohio; the emergency being to ensure the City continues to have sufficient funds available for the purpose of City Street Maintenance and Repair and the City Street Department, and to ensure that the Stark County Board of Elections approves this Resolution as complying with the mandates of Section 718.04 of the Ohio Revised Code to accept the placing of the proposed continuation of an existing two-tenths of one percent (0.2%) levy on income on the ballot within the time deadlines of the Ohio Revised Code. Provided this Resolution receives the affirmation vote of two-thirds of the elected and/or appointed members of Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
