TITLE: AN ORDINANCE authorizing the Director of Public Service and Safety of the City of Massillon, Ohio, to accept an AFG Grant (EMW-2019-FG-10555) from the Federal Emergency Management Agency (FEMA) on behalf of the Massillon Fire Department, and declaring an emergency.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section 1:

The Council of the City of Massillon, Ohio, hereby determines it to be necessary in the public peace, health or safety to accept an AFG Grant (EMW-2019-FG-10555) from the Federal Emergency Management Agency (FEMA) on behalf of the Massillon Fire Department. The amount of the Grant awarded is Thirty-five Thousand, Three Hundred Sixty-three Dollars and Sixty-four Cents (\$35,363.64). The City share is 10% of the Federal Funds awarded in the amount of Three Thousand, Five Hundred Thirty-six Dollars and Thirty-six Cents (\$3,536.36).

Section 2:

The Director of Public Service and Safety of the City of Massillon, Ohio, is hereby authorized and directed to accept an AFG Grant (EMW-2019-FG-10555) from the Federal Emergency Management Agency (FEMA) on behalf of the Massillon Fire Department. The amount of the Grant awarded is Thirty-five Thousand, Three Hundred Sixty-three Dollars and Sixty-four Cents (\$35,363.64). The City share is 10% of the Federal Funds awarded in the amount of Three Thousand, Five Hundred Thirty-six Dollars and Thirty-six Cents (\$3,536.36). The use of the grant is to provide CPR Assist Devices to paramedics to help save lives. The grant will also be used to purchase a cot for bariatric (heavier) patients.

Section 3:

The Clerk of Council is authorized to correct any typographical errors discovered herein during or after the pendency or passage of this ordinance. The Clerk of Council is further authorized, in conjunction with the Law Department and the Council President to correct any ministerial or de minimis errors that do not substantially alter the intended results or numerical total sums of this ordinance, during or after the pendency or passage of this ordinance. Section 4:

This Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, health or safety of the citizens of the City of Massillon; the emergency being to acknowledge acceptance of the grant within thirty (30) days of the notification award which is September 4, 2020. Provided it receives the affirmative vote of two-thirds of the elected members to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

WHEREAS, the City of Massillon, in cooperation with the Ohio Department of Transportation, is undertaking the Wales Road Widening Project, STA SR-241 09.71, PID No. 100471 (the "Project"); and

WHEREAS, the Project involves the widening and resurfacing of approximately 1.59 miles of Wales Road NE from Lincoln Way E. to Hills and Dales Road N.E.; and

WHEREAS, the City of Massillon must acquire interests in real property necessary for construction of the Project.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section 1:
