WHEREAS, the City of Massillon, in cooperation with the Ohio Department of Transportation, is undertaking the Wales Road Widening Project, STA SR-241 09.71, PID No. 100471 (the "Project"); and

WHEREAS, the Project involves the widening and resurfacing of Wales Road NE from Lincoln Way E to the City of Massillon's N. Corp. Limit; and

WHEREAS, the City of Massillon must acquire interests in real property necessary for construction of the Project, including numerous temporary easements; and

WHEREAS, the City of Massillon has been unable to acquire several of the aforementioned temporary easements through good faith negotiations with the impacted property owners.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section 1:

The City of Massillon's appropriation of the temporary easements described below in Section 2 is deemed to be necessary for a public use, said public use being the construction of the Project.

Pursuant to Chapter 719 of the Ohio Revised Code, it is declared to be the intent of the City of Massillon to appropriate temporary easements, legal descriptions of which are attached as Exhibit "A," in and to the parcels of real property described in the attached Exhibit "B," which provides owner names, relevant addresses, established fair market values and court deposit amounts, parcel numbers, and lot numbers.

Section 3:

Immediately upon the passage of this resolution, the Mayor shall cause written notice to be given to the owner of, person in possession of, or person having an interest of record in, every parcel of real property described above in Section 2, or to the authorized agent of the owner or other such person. Such notice shall be served and return shall be made as required in Chapter 719 of the Ohio Revised Code. If such owner, person, or agent cannot be found, notice shall be given by publication and as required in Chapter 719 of the Ohio Revised Code.

Section 4:

The Mayor and the Law Director, or their designee(s), on behalf of the City of Massillon, are authorized to take any and all steps deemed appropriate or necessary to allow the City to acquire the temporary easements described above in Section 2 and for the City to take possession of said temporary easements at the earliest time allowed by law, in accordance with Chapters 163 and 719 of the Ohio Revised Code.

Section 5:



BY: FINANCE COMMITTEE

TITLE: A RESOLUTION authorizing the sale, during calendar year 2020, of city-owned motor vehicles and pieces of related equipment which are not needed for public use, or are obsolete or unfit for the use for which they were acquired, by internet auction, and declaring the same to be an emergency.

WHEREAS, pursuant to Division (D) of Section 721.15 of the Ohio Revised Code, the legislative authority for the City of Massillon may adopt, during each calendar year, a resolution expressing its intent to sell city-owned personal property which is not needed for public use, or is obsolete or unfit for the use for which it was acquired, by internet auction; and

WHEREAS, the City of Massillon currently owns motor vehicles and pieces of related equipment which are not needed for public use, or are obsolete or unfit for the use for which they were acquired.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section 1:

Authorization is given, during calendar year 2020, for city-owned motor vehicles and pieces of related equipment which are not needed for public use, or are obsolete or unfit for the use for which they were acquired, to be sold by internet auction, in accordance with Division (D) of Section 721.15 of the Ohio Revised Code.

Section 2:

All internet auction sales shall be conducted under the authority and direction of the Director of Public Service and Safety, or her designee(s), on behalf of the City of Massillon.

Section 3:

All internet auction sales shall be conducted by GovDeals.com internet auction service (Address: 100 Capitol Commerce Blvd STE 110, Montgomery, AL 36117; Phone: 1-800-613-0156), or another internet auction provider.

Section 4:

All internet auction sales shall be conducted in accordance with the rules and regulations promulgated by and in effect for the chosen internet auction provider. The City of Massillon will maintain a link to all current internet auction providers on its website, www.massillonohio.gov, to inform the public of the providers' name and contact information, as well as the rules and regulations for all current internet auction sales.

Section 5:

For each internet auction sale, bidding shall remain open for not less than ten (10) days, including Saturdays, Sundays, and legal holidays.

Section 6:

For each internet auction sale, the Director of Public Service and Safety, or her designee(s), is authorized to establish any terms and conditions deemed to be appropriate for the particular sale, including a minimum price that will be accepted for each specific cityowned motor vehicle or piece of related equipment.

Section 7:

The Director of Public Service and Safety, or her designee(s), shall ensure all notices called for in Division (D) of Section 712.15 of the Ohio Revised Code are provided as required by law.

Section 8:

The Clerk of Council is authorized to correct any typographical errors discovered herein during or after the pendency or passage of this resolution. The Clerk of Council is further authorized, in conjunction with the Law Department and the Council President, to correct any ministerial or de minimis errors that do no substantially alter the intended results or numerical total sums of this resolution, during or after the pendency or passage of this resolution.
