ORDINANCE NO. 151 – 2020

AN ORDINANCE amending SECTION 181.01 "PURPOSE AND AUTHORITY TO LEVY TAX; RATE" of the Codified Ordinances of the City of Massillon, Ohio, and authorizing the continuation of an existing two-tenths of one percent (0.2%) levy on income, to be effective January 1, 2022, for five (5) years, for the purpose of City Street Maintenance and Repair and the City Street Department, subject to the approval of the electors of the City of Massillon, Ohio, at an election to be conducted at the Primary Election on May 4, 2021.
