Section 1:

Upon the effective date of this Ordinance, that there by and is hereby enacted a new Section 2 of Ordinance No. 126 – 1997. Said new Section 2 shall read as follows:

Personnel of Police Department

Chief of Police (1)

Captain (1) – The Captain shall hold the special title of "Deputy Chief" while maintaining the rank of Captain. This title allows for continuity of leadership among the ranks and clearly defines his/her role in the organization.

Lieutenants (4)

Sergeants (7)

Section 2:

This newly created Section abolishes one (1) Captain position and adds one (1) sergeant position. The abolished position will be accomplished through attrition and no layoffs or demotions will be used to enact the abolishment. One (1) new Sergeant position will be created upon the official retirement date of one (1) current Captain. This new section is necessary for a more efficient and cost-effective Police Department which is vitally essential to providing police services to the community. Reducing the command staff position of Captain in the department and adding a first-line supervisory position of Sergeant, reallocated a leadership role closer to the patrol division where it is need.

Section 3:

All existing ordinances and resolutions in conflict with any provision of this Ordinance are hereby repealed to the extent of the conflict.

Section 4:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section 1:

Ordinance No. 151 – 2019 be and is hereby repealed.

Section 2:

That there be and hereby is enacted a new Section 13 "ALLOCATION OF FUNDS - INCOME TAX" of Ordinance No. 143 - 1976. Said new Section 13 shall read as follows:

Section 13 - ALLOCATION OF FUNDS

- (A) Effective January 1, 2023 the funds collected under the provision of this ordinance shall be disbursed as follows:
 - (1) Ninety-three percent (93%) percent shall be deposited in the "1100 General Fund" and Seven percent (7%) shall be deposited in said "1401 Income Tax Capital Improvements Fund" and shall be used for capital improvements to defray operating expenses of the City including such part thereof as shall be necessary to defray all costs of administering and enforcing the provisions thereof.
 - (2) Capital Improvements are all property, assets, machinery, equipment or improvements which the City is authorized by law to acquire, construct and maintain, including plans and studies thereof with an estimated life or usefulness of five (5) years or more, including land and interests therein, and including reconstructions, enlargements and extension thereof having an estimated life or usefulness of five (5) years or more provided, however, that the purchase of motorized equipment for the various city departments and the resurfacing and resealing of public streets, including

Section 1:

That the Auditor of the City of Massillon, Ohio, is hereby authorized and directed to draw warrants on the Treasurer of the City of Massillon, Ohio, for payments from any of the foregoing appropriations upon proper certification and vouchers approved by the Board of Officers (or Officer) authorized by law to approve the same or any ordinance or resolution of Council to make expenditures; provided that no warrants shall be drawn or paid for salaries or wages except to persons employed in accordance with law or ordinance.

Section 3:

The Auditor of the City of Massillon, Ohio, is hereby authorized to execute the inter-fund transfers outlined in the attached Exhibit "A" and to draw the warrants upon receipt of vouchers duly approved by the proper departmental authority.

Section 4:

The Clerk of Council is authorized to correct any typographical errors discovered herein during or after the pendency or passage of this ordinance. The Clerk of Council is further authorized, in conjunction with the Law Department and the Council President to correct any ministerial or de minimis errors that do not substantially alter the intended results or numerical total sums of this ordinance, during or after the pendency or passage of this ordinance. Section 1:

Council, in the best interest of proper community growth and general welfare of the City, hereby reverse the decision of the Massillon Board of Zoning Appeals in Variance Case No. 2022-16. The variances requested by Mr. Kevin Smith in said case are hereby denied.

The City of Massillon Building Department and the Massillon Board of Zoning Appeals shall take all actions necessary to carry out the provisions of this Resolution and the decision of Council rendered herein.
