A person shall be at least twenty-one years of age and not forty-one years of age or older to be eligible to receive an original appointment to the Police Department as a police officer.

Section 2:

Section 151.01 "Age Requirements" under CHAPTER 151 "FIRE DEPARTMENT" of the Codified Ordinances of the City of Massillon, Ohio, be and is hereby amended to read as follows:

151.02 AGE REQUIREMENTS.

A person shall be at least eighteen years of age and not forty-one years of age or older in order to be eligible to receive an original appointment to the Fire Department as a firefighter.

Section 3:

All Ordinances or parts of Ordinances in conflict with this Ordinance are repealed. If any provision of this Ordinance is judged invalid by a court of competent jurisdiction, such judgment shall not affect or invalidate the remainder.
