The public necessity, convenience, general welfare, and good zoning practices require that the Zoning Map of the City of Massillon, Ohio, established in Section 1151.02 of the Codified Ordinances of the City of Massillon, Ohio, and subsequently amended, be amended to rezone the property described below in Section 2 from O-1 Office District to B-2 Central Business District. The rezoning was recommended by the City of Massillon Planning Commission after a public hearing held on February 9, 2022. All required notices and public hearings have been given and held according to law.
