TITLE: A RESOLUTION directing the Stark County Board of Elections to proceed with conducting an election at the General Election to be held on November 8, 2022, for the purpose of submitting to the electors of the City of Massillon, Ohio, the question of the approval or disapproval of the issue providing for the replacement of a tax for the benefit of the City of Massillon, Ohio, for the purpose of the maintenance and operation of a free public museum of art, science, or history at a rate not exceeding 1.5 mills for each one dollar of valuation, which amounts to 15 cents for each one hundred dollars of valuation, for a period of 5 years, commencing in 2023, first due in calendar year 2024, and declaring the same to be an emergency.

WHEREAS, pursuant to Section 5705.03 of the Ohio Revised Code, this Council adopted Resolution No. 6-2022 on May 2, 2022, determining it necessary to levy a tax outside the tenmill limitation and requesting that the Stark County Auditor certify to this Council the total current tax valuation of the City of Massillon, Ohio, and the dollar amount of revenue that would be generated by a tax that is a replacement of an existing tax at a rate not exceeding 1.5 mills; and

WHEREAS, on May 6, 2022, the Stark County Auditor certified that the total current tax valuation of the City of Massillon, Ohio, is \$734,293,140 and that the estimated property tax revenue that will be produced by the stated millage of the replacement levy, is \$1,101,440 annually during the life of the levy, assuming the tax valuation of the City remains constant throughout the life of the levy.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, TWO-THIRDS OF THE MEMBERS CONCURRING, THAT:

#### Section 1:

Council hereby declares that the amount of taxes that may be raised by the City of Massillon, Ohio, within the ten-mill limitation by levies on the current tax duplicate will be insufficient to provide an adequate amount for the necessary requirements of the City. Council also hereby declares that it is necessary to levy a tax in excess of such limitation to provide for the maintenance and operation of a free public museum of art, science, or history, with said museum being the Massillon Museum, which is maintained and operated by a private, non-profit organization, as authorized by Division (AA) of Section 5705.19 of the Ohio Revised Code.

#### Section 2:

Pursuant to Section 5705.192 of the Ohio Revised Code, Council hereby proposes to replace an existing tax levy for the benefit of the City of Massillon, Ohio, for the purpose of the maintenance and operation of a free public museum of art, science, or history at a rate not exceeding 1.5 mills for each one dollar of valuation, which amounts to 15 cents for each one hundred dollars of valuation, for a period of 5 years, commencing in 2023, first due in calendar year 2024. The proposed rate of the replacement tax levy is the same as the rate of the existing tax levy.

#### Section 3:

There shall be submitted to the electors of the City of Massillon, Ohio, at the General Election to be held on November 8, 2022, the question of the approval or disapproval of the issue providing for the replacement of a tax for the benefit of the City of Massillon, Ohio, for the purpose of the maintenance and operation of a free public museum of art, science, or history at a rate not exceeding 1.5 mills for each one dollar of valuation, which amounts to 15 cents for each one hundred dollars of valuation, for a period of 5 years, commencing in 2023, first due in calendar year 2024.

#### Section 4:

The Clerk of Council is hereby directed to certify a copy of this Resolution, including the attached sample ballot, and all other materials required by law to the Stark County Board of Elections. The Clerk of Council is also hereby directed to request that the Stark County Board of Elections provide notice of the election referenced above as required by law.

# Section 5:

The Clerk of Council is authorized to correct any typographical errors discovered herein during or after the pendency or passage of this ordinance. The Clerk of Council is further authorized, in conjunction with the Law Department and the Council President to correct any ministerial or de minimis errors that do not substantially alter the intended results or numerical total sums of this ordinance, during or after the pendency or passage of this ordinance. # Section 6:

This Resolution is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, or safety of the citizens of the City of Massillon, Ohio; the emergency being to ensure the orderly and timely submission of the proposed tax levy to the Stark County Board of Elections prior to the filing deadline for the 2022 General Election, and to ensure the generation of sufficient tax revenues for the purpose of the maintenance and operation of a free public museum of art, science, or history. Provided this Resolution receives the affirmative vote of two-thirds of the elected and/or appointed members to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

#### Section 1:

The Mayor and/or the Director of Public Service and Safety of the City of Massillon, Ohio, is hereby authorized and directed to enter into a Capital Improvement Community Park, Recreation/Conservation Project Pass Through Grant Agreement with the Ohio Department of Natural Resources (ODNR). The agreement is attached hereto as Exhibit "A".

## Section 2:

The Clerk of Council is authorized to correct any typographical errors discovered herein during or after the pendency or passage of this ordinance. The Clerk of Council is further authorized, in conjunction with the Law Department and the Council President to correct any ministerial or de minimis errors that do not substantially alter the intended results or numerical total sums of this ordinance, during or after the pendency or passage of this ordinance. Corrected copies are to be sent to all official recipients.

#### Section 3:

This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health or safety of the citizens of the City of Massillon, Ohio; the emergency being to ensure the agreement is executed in a timely manner and is in compliance with all grant and funding requirements. Provided this Ordinance receives the affirmative vote of two-thirds of the elected and/or appointed members to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor. Otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

TITLE: AN ORDINANCE granting the Mayor of the City of Massillon, Ohio, a one-time salary increase to \$90,000.00 per year, effective January 1, 2024, and granting the Auditor of the City of Massillon, Ohio, a one-time salary increase to \$77,000.00 per year, effective January 1, 2024.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

#### Section 1:

Effective January 1, 2024, the Mayor of the City of Massillon, Ohio, shall receive a one-time salary increase to \$90,000.00 per year. This one-time salary increase shall be in lieu of, and not in addition to, the CPI salary increase provided for in Ordinance No. 174 – 2019. Said CPI salary increase for the Mayor is hereby suspended for calendar year 2024. Effective January 1, 2025, the Mayor shall commence receiving said CPI salary increase.

## Section 2:

Effective January 1, 2024, the Auditor of the City of Massillon, Ohio, shall receive a one-time salary increase to \$77,000.00 per year. This one-time salary increase shall be in lieu of, and not in addition to, the CPI salary increase provided for in Ordinance No. 174 – 2019. Said CPI salary increase for the Auditor is hereby suspended for calendar year 2024. Effective January 1, 2025, the Auditor shall commence receiving said CPI salary increase.

## Section 3:

In the event of any conflict between the provisions of any existing ordinances or resolutions and the provisions of this Ordinance, the provisions of this Ordinance shall control.

## Section 1:

The Mayor and/or the Director of Public Service and Safety of the City of Massillon, Ohio, are hereby authorized and directed to enter into a commercial real estate purchase agreement with Campbell Oil Company for the purchase of Parcel Nos. 614431 and 601521, further known as 611 Erie Street South, Massillon, OH 44646. A copy of the purchase agreement is attached to this Ordinance as Exhibit "A". The purpose of this purchase is to provide for a new facility for the Massillon City Health Department.

## Section 2:

The Mayor and/or the Director of Public Service and Safety are hereby authorized and directed to enter into an escrow agreement with Alpha Land Title Agency, Inc., to facilitate the purchase referenced above in Section 1. A copy of the escrow agreement is attached to this Ordinance as Exhibit "B". The Mayor and/or the Director of Public Service and Safety are also authorized to take all other actions necessary to facilitate said purchase.

#### Section 3:

Upon successful completion of the purchase referenced above in Section 1, Council authorizes the relocation of the Massillon City Health Department to Parcel Nos. 614431 and 601521, further known as 611 Erie Street South, Massillon, OH 44646.
