#### Section 1:

The public necessity, convenience, general welfare, and good zoning practices require that the Zoning Map of the City of Massillon, Ohio, established in Section 1151.02 of the Codified Ordinances of the City of Massillon, Ohio, and subsequently amended, be amended to rezone the property described below in Section 2 from R-3 One Family Residential. The rezoning was denied by the City of Massillon Planning Commission after a meeting held on November 9, 2022. All required notices and public meetings have been given and held according to law.

#### Section 2:

The property to be rezoned is known as Lot 347 of Parcel #680121 and Lot 571 of Parcel #680731, 1.9390 acres located at 1900 Wales Rd. N.E, Massillon, Ohio.
