We, the Massillon City Board of Health, voted and approved the creation and duties for three new titles to the Health Department staff at the February 21, 2023 meeting. In accordance with Ohio Revised Code 3709.16 - The board of health is given explicit statutory authority to "appoint for full or part time service a health commissioner and may appoint such public health nurses, clerks, physicians, and other persons as are necessary." R.C. 3709.14. Furthermore, "[T]he board of health of a city or general health district shall determine the duties and fix the salaries of its employees."

The Board of Health requests that Massillon City Council add the following titles to the "Occupation List of Class Titles":

Full Time Outreach Coordinator 11S

Part Time Language Services Coordinator 11S

Seasonal Intern

These positions will be paid in full by our Workforce Development Grant, the grant is through November 30, 2027. The grant will alleviate certain expense from the city budget. The Ohio Department of Health has awarded the grant to Ohio health departments to strengthen Public Health and create new jobs to better serve the citizens of Ohio. The positions we have created will promote and protect the health and well-being of our Massillon citizens by increasing our service areas and outreach into our community. Outreach and community engagement are a cornerstone of public health and vital to creating healthy communities.

The Outreach Coordinator will promote activities of the Health Department and provide education and awareness of services that the Health Department provides. The Language Services Coordinator will provide a greater level of service to our non-English-speaking citizens and provide comfort when utilizing Health Department services. Seasonal interns will be utilized on an as needed bases for certain projects, events, etc.





The Board of Health requests that Massillon City Council add these to the "Occupation List of Class Titles", so that the positions can be filled and this vital work can begin promptly.

WHEREAS, during a special meeting of the Massillon Board of Zoning Appeals on February 23, 2023 pursuant to proper notice, the Massillon Board of Zoning Appeals adopted BZA Resolution Case No. 2023-2 in accordance with the requirements of R.C. § 2506.03 memorializing its decision to deny Huth Ready Mix & Supply Company's appeal and uphold the Cease and Desist Order issued by the Zoning Official on November 16, 2022, approving the transcript containing a report of all evidence admitted or proffered by Huth Ready Mix & Supply Company and considered by the Massillon Board of Zoning Appeals in rendering its decision in Case No. 2023-2, and adopting conclusions of fact supporting the final decision of the Massillon Board of Zoning Appeals denying the appeal in Case No. 2023-2;

WHEREAS, on February 24, 2023, written notice was served upon Huth Ready Mix & Supply Company of the Massillon Board of Zoning Appeals' decision denying Huth Ready Mix & Supply Company's appeal and upholding the Cease and Desist Order issued by the Zoning Official on November 16, 2022, including a copy of BZA Resolution Case No. 2023-2, the transcript containing a report of all evidence admitted or proffered by Huth Ready Mix & Supply Company and considered by the Massillon Board of Zoning Appeals' in rendering its decision in Case No. 2023-2, and true and

accurate true and accurate copies all exhibits made part of the official record of the proceedings before the Massillon Board of Zoning Appeals' as identified in said transcript;

WHEREAS, pursuant to Massillon Cod. Ord. 1129.09(a) Huth Ready Mix & Supply Company appealed the Massillon Board of Zoning Appeals' decision in Case No. 2023-2 denying Huth Ready Mix & Supply Company's appeal and upholding the Cease-and-Desist Order issued by the Zoning Official on November 16, 2022 by a notice of appeal to Massillon City Council deemed timely filed as of February 24, 2023;

WHEREAS, Massillon City Council a public hearing was held by Massillon City Council on said appeal on March 20, 2023 in accordance with Massillon Cod. Ord. Chapter 1129 pursuant to proper notice for which the Huth Ready Mix & Supply Company appeared with counsel;

WHEREAS, Massillon City Council has considered the transcript containing a report of all evidence admitted or proffered and considered by the Massillon Board of Zoning Appeals' in rendering its decision in Case No. 2023-2, the exhibits made part of the official record of the proceedings before the Massillon Board of Zoning Appeals' as identified in said transcript, and all information and evidence presented or proffered to Massillon City Council by Huth Ready Mix & Supply Company in connection with said appeal.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section 1:

In accordance with Massillon Cod. Ord. 1129.09(c), Council, in the best interest of proper community growth and general welfare of the City and in furtherance of the legislative intent expressed by Massillon Cod.
