TITLE: AN ORDINANCE to accept the dedication of road right of way and easements for Kenyon Creek Estates, Phase 3 subdivision, Massillon, Ohio.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

#### Section 1:

The Council of the City of Massillon, Ohio, hereby accepts the dedication of road right of way and easements for Kenyon Creek Estates, Phase 3 subdivision, Massillon, Ohio, as shown on the attached maps. At its December 8, 2021 meeting, the City Planning Commission approved said plat for the subdivision. The request includes the dedication of 1.99 acres of roadways including extension of Yellow Creek Ave. N.W. and new streets Heron Creek St. N.W. and Ibis Creek Ave. N.W. There will be 39 additional platted lots in the subdivision and the area is currently zoned R-1 Single Family Residential.

The Clerk of Council is authorized to correct any typographical errors discovered herein during or after the pendency or passage of this ordinance. The Clerk of Council is further authorized, in conjunction with the Law Department and the Council President to correct any ministerial or de minimis errors that do not substantially alter the intended results or numerical total sums of this ordinance, during or after the pendency or passage of this ordinance. This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
