TITLE: AN ORDINANCE amending Section 1 of Ordinance No. 49 – 2014 to reduce and ultimately eliminate the current assessment of a Street Lighting Fee.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section 1:

Section 1 of Ordinance No. 49-2014 is hereby amended.

Section 2:

That the amended Section 1 of Ordinance No. 49-2014 is to read follows:

That each property in the City of Massillon will be charged a street lighting fee in the amount of \$25.00 per year per property commencing April 1, 2014. The street lighting fee will be reduced by 50% effective January 1, 2024. The street lighting fee will be eliminated effective January 1, 2025. The fees assessed from the last quarter of the previous calendar year may be billed in the first quarter of the following year. For the purposes of assessment of the fee if a single-family residential property is serviced by sewer, but situated on more than one lot or parcel of land, it shall only pay one fee annually. However, if the vacant lots or parcels are buildable under the applicable Zoning and Building Code, the owner of such lots shall pay the annual fee for such parcels or lots in addition to the fee for the parcel on which the residence is situated, unless the vacant lot is located directly adjacent to the single-family residential property owner's residence.

Section 3:

AN ORDINANCE TO ASSESS A STREET LIGHTING FEE.

WHEREAS, the City has established a Street Lighting District; and

WHEREAS, the City has created line item Street Lighting Assessment #1100.905.4.1503 for the collection of street lighting fees; and

WHEREAS, the City has the authority pursuant to Ohio Revised Code Section 727.01 and Article XVIII, Section3, of the Ohio Constitution to charge a portion of the costs of street lighting to the property owners in the City; and

WHEREAS, the cost to the City for street lighting is approximately \$410,000.00 annually; and

WHEREAS, the cost associated with street lighting includes but is not limited to operation, repair and maintenance of street lights; and

WHEREAS, the City has no obligation to provide street lighting within the City except in certain areas such as intersections; and

WHEREAS, sufficient street lighting is a benefit to all citizens and property owners and promotes the general health, safety and welfare of the citizens of Massillon as it results in increased visibility and safety for property owners, pedestrians and motor vehicles, as well as acting as a deterrent to criminal activity; and

WHEREAS, City Council has determined that it is fair, appropriate and reasonable that the cost of the operation and maintenance be paid on a fair and reasonable basis by all of the property so benefited and the cost should be charged and collected from all such benefited property, except for those exempted below; and

WHEREAS, the amount of the street lighting fee will be \$25.00 per year per property and such amount is in proportion to the benefits that result from street lighting and will be assessed on the sewer bill each quarter in arrears, commencing April 1, 2014; and

WHEREAS, any and all fees collected will be placed into a fund designated solely for the street lighting; and

WHEREAS, any quarterly fee not paid in full by December 31 of any year will be certified to the Stark County Auditor and will become a lien on the property to be collected as real estate taxes.

BE IT ORDAINED, by the City of Massillon, County of Stark and State of Ohio:

SECTION 1. That each property in the City of Massillon will be charged a street lighting fee in the amount of \$25.00 per year per property commencing April 1, 2014. For the purposes of assessment of the fee if a single family residential property is serviced by sewer, but situated on more than one lot or parcel of land, it shall only pay one fee annually. However, if the vacant lots or parcels are buildable under the applicable Zoning and Building Code, the owner of such lots shall pay the annual fee for such parcels or lots in addition to the fee for the parcel on which the residence is situated, unless the vacant lot is located directly adjacent to the single family residential property owner's residence.

- SECTION 2. That the street lighting fee will be placed on the sewer bill for each property.
- SECTION 3. 10% of collected street lighting fees shall go to the infrastructure improvements of street lighting.
- SECTION 4. That any parcel of real estate not serviced by water and for sewer will be sent an annual bill for the street lighting fee on or about January 1st of each year, except for 2014, which will be billed on or before October 1, 2014 on a prorated basis for 2014.
- SECTION 5. That a charge shall not be made against City owned land, or land owned by the Massillon Area City Schools. Any person or corporation that has a separate contract or agreement with the City relative to lighting shall be charged the street lighting fee in addition to any contractual amount.
- SECTION 6. Any street lighting fee not paid by December 31 of any year shall be certified to the Stark County Auditor and will become a lien on the real estate to be collected as taxes.
- SECTION 7. That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council or any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 8. That this ordinance shall go into effect at the earliest period provided by law.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section 1:

The public necessity, convenience, general welfare, and good zoning practices require that the Zoning Map of the City of Massillon, Ohio, established in Section 1151.02 of the Codified Ordinances of the City of Massillon, Ohio, and subsequently amended, be amended to rezone the property described below in Section 2 from B-2 Central Business District to R-1 One Family Residential. The rezoning was approved by the City of Massillon Planning Commission after a meeting held on June 14, 2023. All required notices and public meetings have been given and held according to law.

Section 2:

The property to be rezoned is known as Lot 1004WH of Parcel #602444, a .09 acre lot on 144 Oak Ave., S.E.; Lot 1005WH of Parcel #600668, a .157 acre lot on 138 Oak Ave., S.E.; and Lot 1006WH of Parcel #612864, a .105 acre lot on 134 Oak Ave. S.E., Massillon, Ohio. The property shall be rezoned from B-2 General Business District to R-1 One Family Residential. The purpose for the rezoning is to allow for new residential construction.
