ORDINANCE NO. 85 - 2023

TITLE: AN ORDINANCE authorizing the Director of Public Service and Safety of the City of Massillon, Ohio, to enter into a contract for the emergency repair of the City's Storm Sewer System without formal bidding and advertising pursuant to Ohio Revised Code 735.051, and declaring an emergency.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

#### Section 1:

That it is hereby declared and determined by this Council that a real and present emergency exists in the Engineering Department of the City requiring immediate repair to the City's storm sewer system at or near 352 Valeside Ave., N.E. in the City of Massillon. Further this Council has been informed and finds that a storm sewer junction vault, located in a densely populated residential neighborhood, has partially collapsed creating a major disruption in the flow of storm water. This disrupted flow has caused damage to the storm sewer pipes and evacuated substantial subsurface soils surrounding the junction vault resulting in a large sinkhole in a resident's backyard. This Council further finds emergency repair is required both to correct the existing damage and to prevent any further damage from future rain events. These measures are required to protect the health and safety of the City's residents from any further damage to the storm sewer system as well as substantial potential damage to multiple residential properties and structures adjacent to and upstream of the current damage to the storm sewer system.

## Section 2:

Further, it is hereby declared and determined by this Council, that because of the real and present emergency described in Section 1., above, this Council directs and authorizes the Safety Service Director to enter into a contract without advertising and competitive bidding to make such emergency repairs to the storm sewer system pursuant to the provisions of Ohio Revised Code 735.051 to protect the health and safety of the City's residents.

#### Section 3:

The Clerk of Council is authorized to correct any typographical errors discovered herein during or after the pendency or passage of this ordinance. The Clerk of Council is further authorized, in conjunction with the Law Department and the Council President to correct any ministerial or de minimis errors that do not substantially alter the intended results or numerical total sums of this ordinance, during or after the pendency or passage of this ordinance. Corrected copies are to be sent to all official recipients.

#### Section 4:

This Ordinance is hereby declared to be an emergency measure for the reason necessary for the immediate preservation of the public peace, health or safety of the citizens of the City of Massillon, Ohio; the emergency being to ensure immediate repair of the damaged storm sewer vault and resulting damage and substantial potential future damage to the City's storm sewer and adjacent residential properties and structures by authorizing to Safety Service Director to enter into a contract for the emergency repair without formal bidding and advertising pursuant to Ohio Revised Code 735.051. Provided this Ordinance receives the affirmative vote of two-thirds of the elected and/or appointed members to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor.

TITLE: AN ORDINANCE authorizing the Director of Public Service and Safety of the City of Massillon, Ohio, to enter into a contract for the emergency repair of the City's Sanitary Sewer System without formal bidding and advertising pursuant to Ohio Revised Code 735.051, and declaring an emergency.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

#### Section 1:

That it is hereby declared and determined by this Council that a real and present emergency exists in the Engineering Department of the City requiring immediate repair to the City's sanitary sewer system at or near the Sippo Sanitary Trunk Sewer in Reservoir Park, in the City of Massillon. Further this Council has been informed and finds that the trunk sewer, located in the park, has previously partially collapsed creating a major disruption in the flow of sanitary sewer. This disrupted flow has caused damage to the sanitary sewer pipes and evacuated substantial pipe interior sections which could result in a large sinkhole and effluent flow discharge into Sippo Creek. This Council further finds emergency repair is required both to correct the existing damage and to prevent any further damages. These measures are required to protect the health and safety of the City's residents from any further damage to the sanitary sewer system as well as substantial potential damage to adjacent properties and structures adjacent to, downstream, and upstream of the current damage to the sanitary sewer system.

## Section 2:

Further, it is hereby declared and determined by this Council, that because of the real and present emergency described in Section 1., above, this Council directs and authorizes the Safety Service Director to enter into a contract without advertising and competitive bidding to make such emergency repairs to the sanitary sewer system pursuant to the provisions of Ohio Revised Code 735.051 to protect the health and safety of the City's residents.

#### Section 3:

The Clerk of Council is authorized to correct any typographical errors discovered herein during or after the pendency or passage of this ordinance. The Clerk of Council is further authorized, in conjunction with the Law Department and the Council President to correct any ministerial or de minimis errors that do not substantially alter the intended results or numerical total sums of this ordinance, during or after the pendency or passage of this ordinance. Corrected copies are to be sent to all official recipients.

#### Section 4:

This Ordinance is hereby declared to be an emergency measure for the reason necessary for the immediate preservation of the public peace, health or safety of the citizens of the City of Massillon, Ohio; the emergency being to ensure immediate repair of the damaged sanitary sewer system and resulting damage and substantial potential future damage to the City's sanitary sewer system and adjacent properties and structures by authorizing to Safety Service Director to enter into a contract for the emergency repair without formal bidding and advertising pursuant to Ohio Revised Code 735.051. Provided this Ordinance receives the affirmative vote of two-thirds of the elected and/or appointed members to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor.
