TITLE: AN ORDINANCE ESTABLISHING AN ECONOMIC DEVELOPMENT GRANT PROGRAM

WHEREAS, this Council has determined that it is necessary and appropriate and in the best interest of the City to promote economic development, business expansion, and job creation, in the City of Massillon, and

WHEREAS, this Council has determined that an Economic Development Grant Program should be established to encourage such economic growth by providing funding for eligible projects in the City of Massillon,

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section 1:

There be and hereby established an Economic Development Grant Program as detailed below in Section 2., along with a Background Information Questionnaire as detailed Section 3.

Section 2:

ECONOMIC DEVELOPMENT GRANT PROGRAM

Overview

The purpose of the Economic Development Grant Program is to promote economic development, business expansion, and job creation by providing funding for eligible projects in the City of Massillon.

Eligibility

Funding decisions are based on a number of project factors, including but not limited to job creation, additional payroll, fixed-asset investment commitment, project return on investment, and project location. The program requires the creation of jobs within a specified period and may consider the amount of proceeds per job created. The City of Massillon may consider providing assistance for eligible projects that improve operational efficiencies or production expansion, along with the retention of jobs. Awards can be made to eligible grantees no more than once in a two-year period.

The Economic Development Grant Program focuses on the following activities:

- Building improvements
- Leasehold improvements
- Purchase or upgrade of machinery or equipment
- Moving and relocation costs of machinery and equipment related to the project
- Infrastructure improvements
- Site development

Ineligible Uses

- Bonds or other debt instruments issued by Grantee to finance completion of the site improvement project shall not be retired or otherwise serviced with grant funds
- Administrative costs (including salaries and travel expenses)
- Inventory of goods for sale
- Contributions and donations by the Grantee to individuals or to other organizations
- Costs (fines, penalties, assessments) resulting from violation of or failure to comply with Federal, state, and local laws and regulations
- Food, drinks and entertainment
- Goods and services for personal use by the Grantee's employees
- Interest on borrowed money
- Organized fundraising
- Taxes from which the Grantee is normally exempt
- Lease and rent payments
- Refinancing or paying off existing debt
- Property acquisition
- Site plan or building permit fees
- Property appraisal costs, legal fees, or loan origination fees
- Building demolition
- Environmental consulting, testing, or actual abatement/clean-up costs
- Routine maintenance of building

Application Process

Applications for this program are available at the City of Massillon Office of Economic Development and must include a completed Background Information document. Massillon City Council retains sole authority to approve or deny and Economic Development Grant agreement and is under no obligation to approve any application or agreement.

Disbursement of Funds

The Economic Development Grant Program is reimbursement-based and requires supporting documentation of expenses paid to receive payment.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MASSILLON, STATE OF OHIO, THAT:

Section 1:

CHAPTER 962 “CEMETERIES” under TITLE FIVE – OTHER PUBLIC SERVICES of PART NINE – STREETS, UTILITIES, AND PUBLIC SERVICES CODE of the Codified Ordinances of the City of Massillon, Ohio, be enacted and to read as follows:

CHAPTER 962
Cemeteries

962.01 Disposition of deceased indigents.

962.02 Cost to be paid for indigent burials.

CROSS REFERENCES

Burials may be prohibited - see Ohio R.C. § 759.05

Management and control - see Ohio R.C. § 759.09

Burial permits - see Ohio R.C. § 3705.24 et seq.

Burial of indigent persons - see Ohio R.C. § 9.15

962.01 DISPOSITION OF DECEASED INDIGENTS.

Whenever the City is legally responsible for the disposition and related costs of deceased persons found to be indigent, the City assigns that

responsibility to the Massillon City Board of Health according to the terms and conditions set forth in this Chapter.

962.02 COST TO BE PAID FOR INDIGENT BURIALS.

According to the written agreement between the City and the Massillon City Board of Health, the Health Commissioner, or their designee, on an annual basis, shall solicit, receive, and review informal bids to establish for that period, cost to be paid by the City when it is legally liable for the disposition by burial, cremation or other legally authorized method, of deceased persons found to be indigent.

Based on the cost proposals received, the Health Commissioner, or designee, shall establish for the annual period, uniform rates to be paid for the disposition of indigent persons.

Section 2:

All Ordinances or parts of Ordinances in conflict with this Ordinance are repealed. If any provision of this Ordinance is judged invalid by a court of competent jurisdiction, such judgment shall not affect or invalidate the remainder.

The Clerk of Council is authorized to correct any typographical errors discovered herein during or after the pendency or passage of this ordinance.
