Section 1:

The Director of Law of the City of Massillon, Ohio, is hereby authorized and directed to enter into a one (1) year agreement with the Village of Wilmot, Ohio, for the purpose of providing prosecutorial services. The Village of Wilmot, Ohio, shall pay the sum of Two Thousand Dollars and Zero Cents (\$2,000.00) under the terms of the Agreement. The Agreement will be from January 1, 2024 through December 31, 2024. These funds will go into the General Fund. Said Agreement is attached as Exhibit "A".

Provided this Ordinance receives the affirmative vote of two-thirds of the elected and/or appointed members to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor. Otherwise, it shall take effect and be in force from and after the earliest period allow by law.
