Rezoning Request

South Massillon Annexation - a 408 acre tract of land, consisting of Out Lots No. 537, 538, 539, 540, 541, 542, 543, 544, 545, 546,547, 548, 549, 550, and 551; and also including Out Lot No. 536 (Massillon Wastewater Treatment Plant). The property is being proposed for R-l Single-Family Residential and I-l Light Industrial zoning as indicated on the attached map. The request is being submitted by Francis H. Cicchinelli, Jr., Chairman, Community Development and Annexation Committee, Massillon City Council.

Preliminary Plat

Terrace Hills - a 28 acre tract of land, consisting of Part of Out Lots No. 330 and 417, and located on the north side of Lincoln Way, East, across from 23rd Street, S.E. The request is proposed to be subdivided into 16 lots for the development of a 100 bed nursing home facility, a 100 unit elderly apartment complex, 2 office buildings, 104 condominium units, and 10 single family homes. The plat has been submitted by Joseph Newman, project developer.





The Massillon Planning Commission met in regular session at 4:00 p.m. on Wednesday, February 9, 1983, in City Council Chambers. It was acknowledged that Bernie Green, Rudy Turkal, and Doris Hintz had contacted the Chairman or Clerk because they would not be able to attend the meeting. All three were excused. The first item of business was approval of the minutes of the December 8, meeting, which were approved as prepared.

The next item was a preliminary plat on Lincoln Hills Development - a 30% acre tract of land, located on the north side of Lincoln Way, N.W., west of 27th Street, N.W., and known as and being Part of Out Lot No. 178 and Part of Out Lot No. 182 in the City of Massillon. George Protos, project developer, is proposing the subdivision of this property into 88 lots. Dennis D. Fulk is the project engineer. Mr. Wagoner presented the request. He explained that this preliminary plat had been presented to the Commission about 10 years ago by another developer, but the project could not proceed because of a problem with the sewer lines in the area. This problem has since been corrected. Aside from the fact that the site would have to be designed properly to address the curb problem, Mr. wagoner had no objections to the proposed project. Mr. Protos and Dennis Fulk were both present. Mr. Protos commented that he was willing to make any changes recommended by the Planning Commission or Planning Department He also had an alternate plan available, which he displayed. He commented further that Mr. Brennan, ward Councilman was happy with this project. At present, the development would consist of between 88 and 91 new homes being built. Later an additional acquistion would be made in the area and it would also be developed in the same manner. The total number of homes for this development would be 126, and the selling price is to be between \$49,000-59,000. Fifteen to twenty homes would be built this summer. Ted Willoughby moved for approval of the request, seconded by Rev. Dodson, the motion carried.

The final item of business was election of officers. Fred Wilson was re-elected Chairman and Rev. Dodson was elected Vice Chairman, both unanimously. There being no further business, the meeting adjourned at 4:30p.m
