Alley Vacation - City Youth Center

Location: A 16 foot alley, located on the north side of Walnut Road, S.E., west of 15th Street, S.E.; specifically, to vacate that portion of the alley from the south property line of Lot No. 5216 to the north property line, a distance of 51.45 feet. This request has been submitted by the City of Massillon in conjunction with the development of an outdoor playground area at the City Youth Center, 1428 Walnut Road, S.E.

Street Dedication - Indian River Road, S.W.

Location: Indian River Road, S.W., running in a north-south direction, from State Route 21 to Indian River School. This request has been submitted by the City of Massillon.

Street Dedication - Walnut Hills Neighborhood

T. Roy Roberson, 4th Ward Councilman, has submitted a request that the City dedicate a number of streets in the Walnut Hills Neighborhood. These areas to be dedicated are driveway easements that are presently being privately maintained. Councilman Roberson is requesting that the City dedicate these areas as streets so that they can be publicly maintained.

The first item on the agenda was the approval of the minutes. The minutes were approved as prepared with the exception of the correction of Ron Sibila's name, the minutes referred to Don Sibila. The Commission Chairman and members welcomed Dr. Hart as a new member.

The next item was a rezoning request, Stonehedge Annexation Area, Location a 5.156 acre tract located on the west side of 17th Street, N.W., between Lincoln Way, N.W., and Cherry Road, N.W., recently annexed into the City of Massillon. Previously located within Tuscarawas Township, which has no zoning, it is being recommended that the area be zoned RM-1 Multiple Family Residential. The request was submitted by Frank Cicchinelli, Chairman, Community Development and Annexation Committee, City Council. This request was presented by Mr. Wagoner. The annexated area is irregularly shaped. It only consist of Stonehedge Apartments and is bordered by 17th Street, Wooster St., the Norfolk and Western Railroad and contains 60 units. It was built by Cardinal Industries in Columbus. Doris Hintz moved to recommend RM-1 Multiple Family Zoning, seconded by Rudy Turkal, motion carried.

The next item for the eveningwas a Final Plat and Street Dedication. Location: A 19.9403 acre tract of land located at the south east corner of Oberlin Road, S.W., and 9th Street, S.W. This request involves the platting and replatting of Out Lot Nos. 289, 290, 576, 577, and Lot No. 10364; as well as the dedicaton of additional width to the east of side of 9th Street, S.W., from Oberlin Road, S.W., southerly a distance of 461 feet. This request is being submitted by the City of Massillon and the Massillon Development Foundation. This request is also from a recently annexed area. Mr. Wagoner made the presentation. It would allow better access to Iron City Sash and other property owners in the area. Prior to the annexation, the Commission heard a request for a preliminary plat. The Sanitary sewer may have to be extended and the area needs some paving. Dr. Hart asked if there would be any conflict with 241. Mr. Wagoner replied that it would not. Rudy Turkal moved to recommend approval of the plat, Rev. Dodson seconded, and the motion carried.

After some discussion concerning Wales Park Development, the election of officers was held. The officers for 1986 are Fred Wilson, Chairman and Bernie Green, Vice Chairman.




