His reasons for this is that the Street Vacation would hamper the ability to rent or sell this property. The first item of business was the minutes of the February 12, meeting. The minutes were approved as prepared.

Chairman Wilson requested that the order of business be changed to hear Mr.Cicchinelli's report concerning the development of a comprehensive, long-range plan for Massillon as the next item of business. Mr. Cicchinelli had another meeting to attend. The request to change the order was approved.

Mr. Cicchinelli reported that City Council had passed Resolution #6, which calls for cooperation of several organizations within the community in developing this plan. Council is seeking assistance and input from citizens and organizations. Mr. Cicchinelli requested assistance from the Commission. He explained that the area of most concern at this time is the downtown area.

The next item of business under Petitions and Requests was an alley vacation - City Youth Center. Location: A 16 foot alley, located on the north side of Walnut Road, S.E., west of 15th Street, S.E.; specifically, to vacate that portion of the alley from the south property line of Lot No. 5216 to the north property line, a distance of 51.45 feet. This request has been submitted by the City of Massillon in conjunction with the development of n outdoor playground area at the City Youth Center, 1428 Walnut Road, S.E. Aane Aaby presented the request. Both lots adjoining the alley are owned by the City. It would make one continuous piece of property. The entire Youth Center property would be fenced in to keep the children inside. The alley vacation is needed to erect the fence. The Commission reviewed the site plan for the playground. Mr. Green moved for approvalof the request, seconded by Henry Joiner, motion carried unanimously.

The next item was a Street Dedication-Indian River Road, S.W. The Location is Indian River Road, S.W., running in a north-south direction, from State Route 21 to Indian River School. This request has been submitted by the City of Massillon. This request was presented by Mr. Wagoner. The road is owned by the State and was built to serve the facility. It is needed for future industry in the area. After some discussion, the Mayor moved to recommend approval of the dedication, seconded by Mr. Green, motion carried unanimously.

The final item for the evening was also a Street Dedication. T. Roy Roberson, 4th Ward Councilman, has submitted a request that the City dedicate a number of streets in the Walnut Hills Neighborhood. These areas to be dedicated are driveway easements that are presently being privately maintained. Councilman Roberson is requesting that the City dedicate these areas as streets so that they can be publicly maintained. Mr. Wagoner presented this request. The homes in the area were built in 1943by the government as war houses. 'hey were later sold to individuals. The plan is to dedicate the easements and then improve them with Community Development funds. All property owners would have to sign for the dedication. Mr. Wagoner estimates the improvements would cost about \$22,000.

T. Roy Roberson and Henry Wasik (a property owner in the area) presented a photographed layout of the area showing the condition of the easements. The both expressed their concern for the residents in the area. The Mayor aid he didn't agree with the idea of the City making the improvements unless the property owners would be assessed according to ability to pay. He commented further that approximately 50% of the properties in the area are rental propertical Ruth Nichols, 1720 Shawnee, S.E., commented on the need for the improvements. There was alot of discussion on the proposed dedication. Henry Joiner then moved to recommend approval of the concept to dedicate the easement, seconded by the Mayor, motion carried.6-1.

There being no further business before the Commission, the meeting adjourne at $8:35~\mathrm{p.m.}$




