Replat

Location: Parts of Lots No. 3676, 3677, and 3678 located at 2639 Lincoln Way East (Burger King Restaurant). The request is these to replat this property into one lot, which will be 1.136 acres in size. The property owner is the Lincoln Company. The replat has been prepared and submitted by Hoover and Associates, Inc.

Street Dedication and Replat

Location: Lot No. 14383 and Part of Out Lot 182 located at 2834 Popular Avenue, N.W. The request is to replat these two parcels into one lot. In addition, the replat includes the dedication of that portion of Popular Avenue, N.W. abutting this property. The property owners are Veryl and Ruth Turskey. The replat has been prepared and submitted by Orville DeBos.

Street Dedication and Replat

Location: Part of Out Lot 562 and Out Lot 563 located on the north side of Nave Road, S.E., east of Veterans Boulevard, S.E. The request is to replat this property into three separate parcels: 1) a 20.0364 acre parcel that will be sold to Ashland University; 2) a 12.2333 acre parcel that is proposed to sold by the City for residential development; and 3) a 5.1372 acre parcel that will be retained by the City. Also included in this plat is the dedication of a new road, University Drive, S.E., as well as the dedication of that portion of Nave Road, S.E., abutting this property. The property owner is the City of Massillon.

The minutes for the Commission Meeting of September 11, 1996, were approved as prepared.

The next item on the Agenda under Petitions and Requests was a Rezoning.

Location: Out Lots 580 and Part of Out Lots 579 and 581, a 60.57 acre parcel located on the West side of State Route 21, between U.S. 30 and Warmington Road, S.W. The request is to rezone this property from I-1 General Industrial to B-3 General Business. This request has been submitted by Michael Sapp of Hannan Realty, who wishes to develop this property into a retail shopping center.

Aane Aaby presented the request. The property consists of 2600 feet of frontage with a depth of 1000 feet. Hannan Realty has an option to purchase this property providing the rezoning is successful. They have provided a preliminary to the site plan to build a shopping center. The petition contains signatures of all property owners in the area.

Kenneth Young was present and commented about the project. Mayor Cicchinelli added that the size of this proposed shopping center is twice that of Oak Park Shopping Center. Also he feels Hannan Realty should be commended for providing so much information this early in the process.

After further comments by Commission Members, Moe Rickett moved for approval, seconded by Tom Wilson, motion carried.
