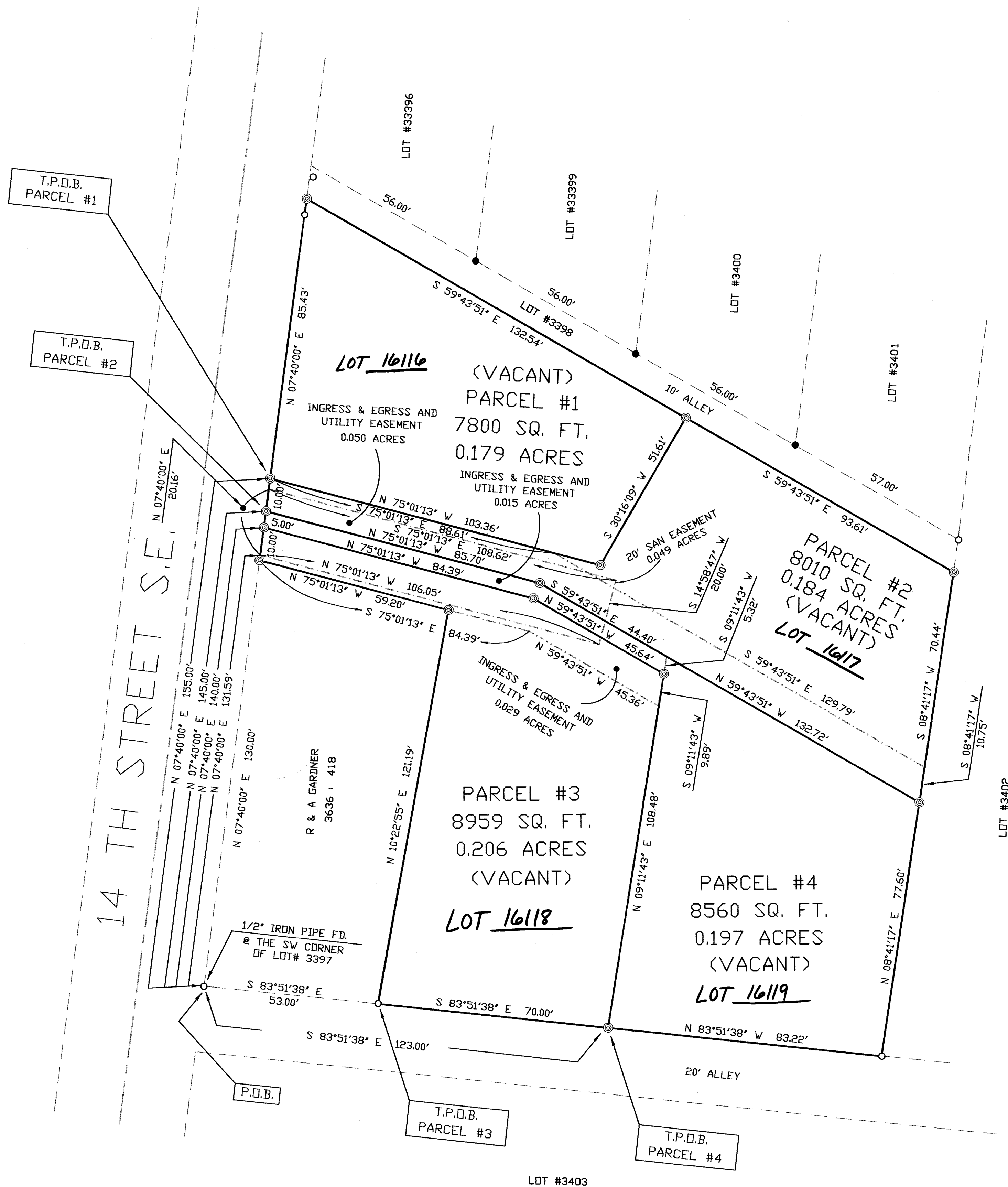
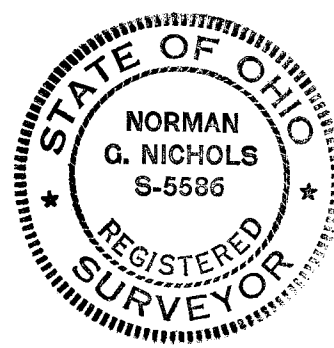


BEARING BASIS
