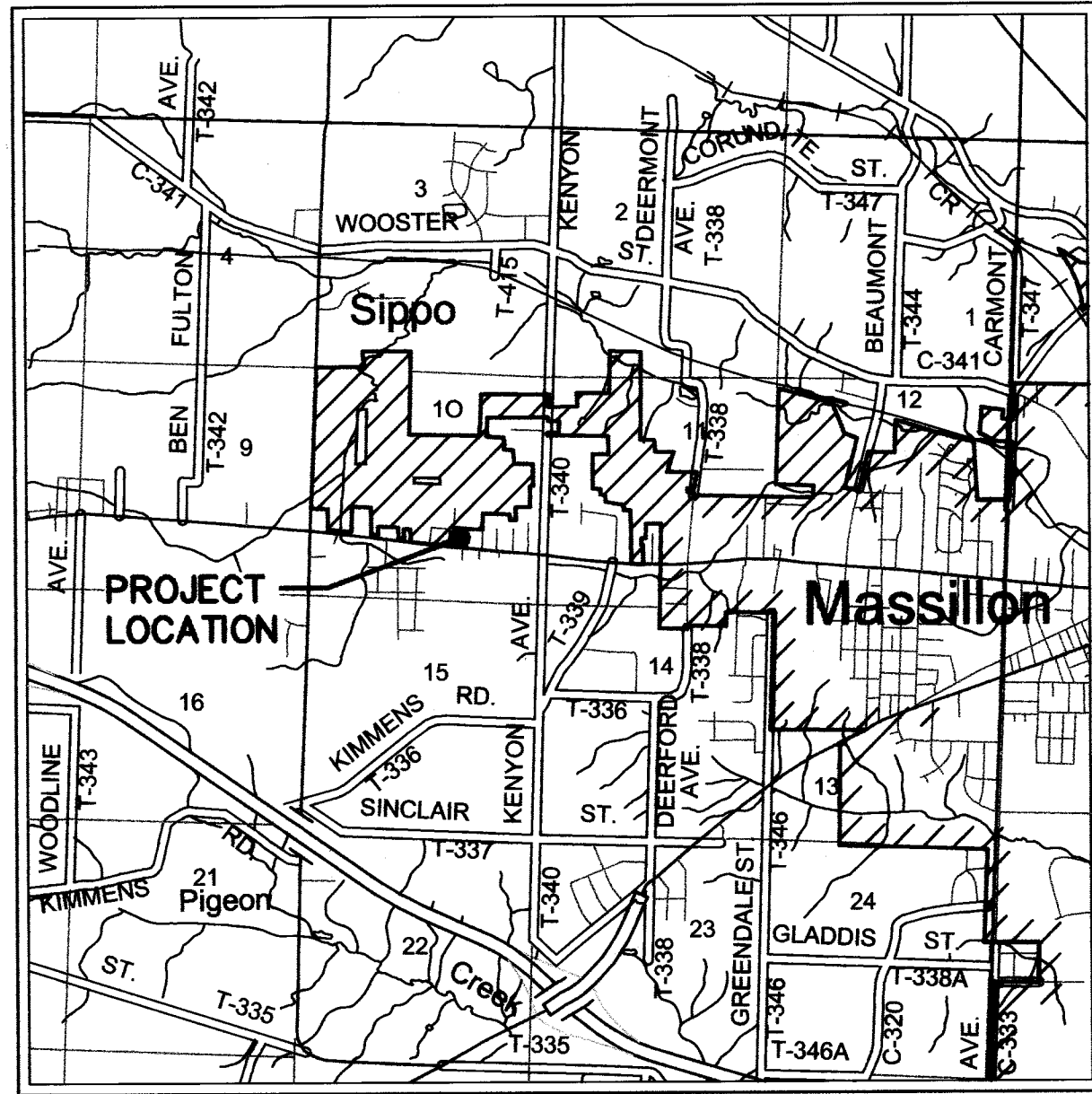




LOCATION MAP

SANITARY SEWER EASEMENT PLAT

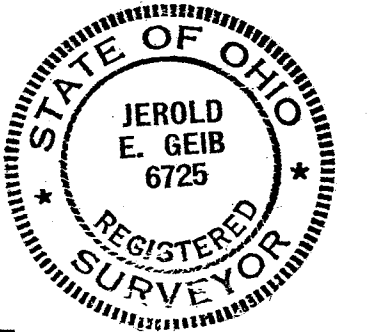
