EXISTING PUBLIC DRAINAGE/SANITARY EASEMENT



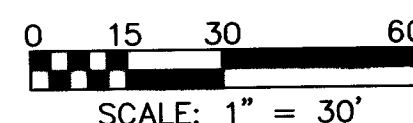
PORTION OF EXISTING PUBLIC DRAINAGE/SANITARY EASEMENT TO BE VACATED
